The applicant will obtain a sign from the Division of Planning for a fee that covers the cost of the sign. The developer shall provide an affidavit to the Division of Planning stating that the sign was posted and maintained on the property during the notice period to the best of the developer's knowledge and ability. When the development plan includes a change in land use that is not reviewed as part of a zone change. The motion was seconded by Mr. Morton.

The motion passed by unanimous vote.

Ms. Lynch moved to amend the motion to include the following in Section 21-4(f) *filing*: Such notice shall include the following information: the filing date of the plan, the address of the subject property, the application record number, and the contact information for the Division of Planning.
