

TEMPORARY CONSTRUCTION EASEMENT

This **TEMPORARY CONSTRUCTION EASEMENT** is made and entered into this the 25 day of April, 2016, by and between **ROBYN L. POSTLEY**, a single person, 232 Pleasant Pointe Drive, Lexington, Kentucky 40517, which is the in-care of tax mailing address for the current year ("Grantor"), and **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

W I T N E S S E I H:

That for and in consideration of the sum of **ONE THOUSAND TWO HUNDRED EIGHTY-EIGHT DOLLARS AND 00/100 (\$1,288.00)**, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantor has **BARGAINED** and **SOLD** and does hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Beginning at a point 30.86 feet left on Mt. Tabor Road station 15+75.35;

Thence North 39 degrees 59 minutes 57 seconds West, 19.91 feet to a point 50.77 feet left of Mt. Tabor Road station 15+75.34;

Thence North 49 degrees 58 minutes 30 seconds East, 39.90 feet to a point 50.77 feet left of Mt. Tabor Road station 16+15.34;

Thence South 39 degrees 59 minutes 59 seconds East, 19.55 feet to a point 31.22 feet left of Mt. Tabor Road station 16+15.31;

Thence South 49 degrees 27 minutes 34 seconds West, 39.90 feet to the point of beginning;

The above described parcel contains .018 acres (787 sq. ft.) of temporary easement; and,

Being a portion of the property conveyed to Robyn L. Postley, a single person, by deed dated February 10, 2011, of record in Deed Book 2993, Page 341, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project on this land and is binding upon the successors and assigns of the Grantor. The temporary construction easement shall take effect upon the commencement of construction of the project and shall be binding until the completion of the project.

Grantor does hereby release and relinquish unto the Grantee, its successors and assigns forever, that she is lawfully seized in fee simple of said property and has good

right to sell and convey the same as herein done, and that she will **WARRANT GENERALLY** said title.

The obtaining of this easement was authorized by Resolution 605-2015, passed by the Lexington-Fayette Urban County Council on October 8, 2015. Pursuant to KRS 382-135(2)(a), this public utility easement is exempt from real estate transfer tax pursuant to KRS 142.050.


