Lexington, Kentucky June 15, 2023

(1) On February 27, 2023, an internal formal complaint was filed on Derrick Walton for violation of General Order 1973-02K Disciplinary Procedures of Sworn Officers, Appendix B, Operational Rule 1.01, Adherence to Laws, Regulation and Orders.

On February 2, 2023 Detective Derrick Walton pled guilty to Operating a Motor Vehicle under the influence of Alcohol KRS 189A.010(1B)-1<sup>st</sup> offense (Aggravating Circumstances) and Reckless Driving KRS 189.290.

At the conclusion of the investigation and after a review of the recommendation of the Disciplinary Review, the employee met with Chief Weathers and accepted a two month suspension without pay and attend a Kentucky Post-Critical Incident Seminar offered through DOCJT in the future.

This is Officer Walton's first sustained formal complaint since his employment began on May 4, 2015.

The appropriate punishment for this conduct is Two (2) month suspension without pay and attend a Kentucky Post-Critical Incident Seminar offered through DOCJT in the future.

Upon motion by Mr. Worley, seconded by Ms. Elliott Baxter and approved by majority vote (Ms. Fogle voted no), the disciplinary recommendation was approved.

Ms. Fogle spoke about the severity level of the disciplinary action in relation to the charges. Chief Weathers responded. She asked about the impact of civil charges on the officer's patrol shifts. Chief Weathers responded.

Ms. Elliott Baxter asked about the precedence of cases of a similar nature. Chief Weathers responded.

Ms. Reynolds inquired if the incidence occurred off the clock. Chief Weathers responded.
