Administrative Synopsis - New Business Items

- a [0609-19](#) Authorization to approve a lease agreement with Lexington & Fayette County Parking Authority for space located at 162 East Main Street within the Annex Building. The area is located on the second floor of the facility and consists of approximately 703 sq/ft of space. Fiscal year impact is \$10,509.84 in revenue. (L0609-19) (Baradaran/Reed)
- b [0622-19](#) Authorization to amend Section 5-29(2) of the Code of Ordinances related to fee schedule to change the fee schedule for restaurant use to \$.090 per square foot, to add a fee schedule for educational use of \$.090 per square foot, to change the fee for motel and motel use to \$.068 per square foot, to change the fee for office use to \$.062 per square foot, to change the fee for retail sales use to \$.042 per square foot, to change the fee for canopies to \$.042 per square foot, to change the fee for warehouse use to \$.028 per square foot and to change the fee for all other non-residential uses to \$.042 per square foot. (UDT) to provide a solution for modernizing the Microsoft Exchange and Microsoft SharePoint productivity platforms. Fiscal year impact \$53,214.00 and funds are budgeted. Annual impact is \$56,670.00 and funds were requested in FY2020 budget. (L0633-19) (Nugent/Valicenti)
- e [0634-19](#) Authorization to approve a third lease extension for LexArts, Inc. at 161 N. Mill Street, beginning July 1, 2019 to September 30, 2019. No budgetary impact. (L0634-19) (Baradaran/Reed)
