Motion by Bledsoe that the budget amendment request list on page 5 of the work session packet be amended to add budget journal 117693 to provide \$406,528.33 in MAP funds for engineering related to the Southland Sidewalk Project. These funds were budgeted in

<u>FY2019</u> in the Municipal Aid Program Fund but were not encumbered before the end of the fiscal year. Seconded by J. Brown. Motion passed without dissent.

Motion by Mossotti to place on the docket for Tuesday, July 9, 2019, Council Meeting, a Resolution authorizing and directing the Mayor to execute and submit a Grant Application to the Kentucky State Police – Vehicle Enforcement Division, to provide any additional information requested in connection with this Grant Application, and to accept this grant if the Application is approved, which Grant funds are in the amount of \$68,000.00 Federal funds, and are for the continued operation of the Motor Carrier Safety Assistance Program (MCSAP) for FY 2020, the acceptance of which obligates the Urban County Government for the expenditure of \$12,000.00 as a local match. Seconded by Plomin. Motion passed without dissent.

Motion by Mossotti to place on the docket for the July 9th Council Meeting a resolution authorizing the Mayor, on behalf of the Urban County Government, to execute partial releases of easement, releasing a portion of the utility easement on the property located at 3900 Boston Road and a portion of the sanitary sewer easement on the property located at 761 Mill Ridge Road, provided that the Department of Environmental Quality and Public Works determines that such easements are no longer required. Seconded by Kay. Motion passed without dissent.

Seconded by McCurn. Motion passed without dissent.
