A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE PURCHASE OF SERVICE AGREEMENTS WITH BABY HEALTH SERVICE (\$12,500), BLUEGRASS COMMUNITY ACTION AGENCY (\$19,500), BLUEGRASS DOMESTIC VIOLENCE PROGRAM (\$63,750), BLUEGRASS RAPE CRISIS CENTER (\$31,220), BLUEGRASS TECHNOLOGY CENTER (\$24,870), CARNEGIE LITERACY CENTER (\$21,000), CENTER FOR WOMEN, CHILDREN AND FAMILIES (\$80,000), CHRYSALIS HOUSE (\$103,700), COMMUNITY ACTION COUNCIL (\$147,975), HOPE CENTER (\$666,000), KENTUCKY PINK CONNECTION (\$24,375), KENTUCKY REFUGEE MINISTRIES (\$31,519), M.A.S.H. SERVICES OF THE BLUEGRASS (\$120,870), MISSION LEXINGTON, INC. (\$24,961), MOVEABLE FEAST LEXINGTON (\$24,700), NURSING HOME OMBUDSMAN PROGRAM (\$33,750), PREVENT CHILD ABUSE KENTUCKY (\$10,756), SALVATION ARMY (\$224,400), SUNFLOWER KIDS (\$14,157), URBAN LEAGUE OF LEXINGTON-FAYETTE COUNTY (\$63,375), AND YMCA OF CENTRAL KENTUCKY (\$15,000), TO PROVIDE SERVICES TO THE PUBLIC, AT A COST NOT TO EXCEED \$1,758,378.00.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute the Purchase of Service Agreements, which are attached hereto and incorporated herein by reference, with Baby Health Service, Bluegrass Community Action Agency, Bluegrass Domestic Violence Program, Bluegrass Rape Crisis Center, Bluegrass Technology Center, Carnegie Literacy Center, Center for Women, Children and Families, Chrysalis House, Community Action Council, Hope Center, Kentucky Pink Connection, Kentucky Refugee Ministries, M.A.S.H. Services of the Bluegrass, Mission Lexington, Inc., Moveable Feast Lexington, Nursing Home Ombudsman Program, Prevent Child Abuse Kentucky, Salvation Army, Sunflower Kids, Urban League of Lexington-Fayette County, and YMCA of Central Kentucky, to provide services to the public.

Section 2 - That an amount, not to exceed the sum of \$1,758,378.00, be and hereby is approved for payment to Baby Health Service (\$12,500 from account #1101-900301-71101), Bluegrass Community Action Agency (\$19,500 from account #1101-900303-71101), Bluegrass Domestic Violence Program (\$63,750 from account #1101-900304-71101), Bluegrass Rape Crisis Center (\$31,220 from account #1101-900316-71101), Bluegrass Technology Center (\$24,870 from account #1101-900305-71101), Carnegie Literacy Center (\$21,000 from account #1101-900608-82101), Center For Women, Children and Families (\$80,000 from account #1101-900306-71101),

Chrysalis House (\$103,700 from account #1101-900209-71101), Community Action Council (\$147,975 from account #1101-900307-71101), Hope Center (\$666,000 from account #1101-900311-71101), Kentucky Pink Connection (\$24,375 from account #1101-900338-71101), Kentucky Refugee Ministries (\$31,519 from account #1101-900339-71101), M.A.S.H. Services Of The Bluegrass (\$120,870 from account #1101-900313-71101), Mission Lexington, Inc.
