Sustainability Grant

Lexington – Fayette Urban County Government

Department of Environmental Quality & Public Works vision is to preserve, protect, and enhance our Bluegrass environment; to provide public infrastructure systems that are safe, efficient, and economical; and to promote a healthy and sustainable quality of life for our citizens.

Sustainability Grant (SG)

The purpose of the SG is to encourage residents to work collaboratively and creatively to educate local citizens on environmental issues and ways they can improve the environmental health of our neighborhoods. A 50% match is required for this grant. A match can be donations, materials or in-kind services or a combination of each. Documentation must be provided for both grant expenditures and on the value of all in-kind supplies, donations, materials and services. In-kind matches may also include items such as recorded use of personal vehicles or machinery. Documented volunteer hours will be valued at the federal minimum wage rate.

Eligible Projects on environmental issues in Fayette County include:

- Anti-Litter
- Beautification (outside only)
- Cleanup & restoration of illegal dumpsites
- Community Gardens
- Composting
- Green Roofs
- Permeable Pavers
- Streamside Restoration

- Rain Barrels (Lily Raintainers can only be used as a grant match)
- Rain Gardens
- Recycling Project
- Wildlife Habitat
- Other projects that are determined to improve the environmental health and meet the principles of sustainability

Ineligible Projects include:

- Building construction and repair
- Maintenance Projects (sidewalk repair)
- Privately created illegal dump clean up
- Other projects that are determined to be maintenance in nature

Review Criteria

The Grant Review Committee will make recommendations to the Urban County Council for final approval and grant award using the grant criteria. Incomplete applications or applications received after the submission deadline will not be considered. Partially funded projects may be offered. The grantee(s) will have the option of accepting or rejecting the partial funding.
