## TEMPORARY CONSTRUCTION EASEMENT

That for and in consideration of the sum of FIVE HUNDRED SEVENTY-FIVE DOLLARS AND 00/100 (\$575.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantors have BARGAINED and SOLD and do hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Temporary Construction Easement (a portion of 2614 Clays Mill Road)

Clays Mill Road Improvement Project, Section 1 (Harrodsburg Road to New Circle Road)

#### Parcel No. 55

Being a tract of land lying in Fayette County on the east side of Clays Mill Road, point of beginning, being approximately 315 feet south of the intersection of Hill N Dale and Clays Mill Road, and more particularly described as follows:

Beginning at a point 38.02 feet right of Clays Mill Road at Station 148+29.57; thence North 36 Degrees 16 Minutes 13 Seconds East a distance of 69.99 feet to a point 40.14 feet right of Clays Mill Road at Station 148+97.97; thence South 63 Degrees 34 Minutes 39 Seconds East a distance of 6.88 feet to a point 46.98 feet right of Clays Mill Road at Station 148+98.72; thence South 36 Degrees 16 Minutes 13 Seconds West a distance of 70.03 feet to a point 44.82 feet of Clays Mill Road at Station 148+30.57; thence North 63 Degrees 11 Minutes 30 Seconds West a distance of 6.87 feet to a point 38.02 feet right of Clays Mill Road at Station 148+29.57 and the POINT OF BEGINNING; and

The above described parcel contains 0.011 Acres (475 sq. ft.) of temporary construction easement; and,

Being a portion of the property conveyed to Adam Jaycox and Robin Jaycox, husband and wife, by deed dated December 19, 2012, of record in Deed Book 3121, Page 563, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project on this land and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have

good right to sell and convey the same as herein done, and that they will **WARRANT**GENERALLY said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS 382-135(2)(a), this public utility easement is exempt from real estate transfer tax pursuant to KRS 142.050.
