

RESOLUTION NO. 86 - 2014

A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBERS OF 109 QUINTON COURT TO 300 QUINTON COURT AND OF 3005 TATES CREEK ROAD TO 3001 TATES CREEK ROAD AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 7095 OLD RICHMOND ROAD TO 1099 SOUTH CLEVELAND ROAD AND OF 4136 PLANTAGENET DRIVE TO 1604 TROPICANA DRIVE, ALL EFFECTIVE THIRTY DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following properties be and hereby are changed as follows:

(a) Quinton Court:

<u>Current</u>	<u>New</u>
109 Quinton Court	300 Quinton Court

(b) Tates Creek Road:

<u>Current</u>	<u>New</u>
3005 Tates Creek Road	3001 Tates Creek Road

Section 2 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

(a) Old Richmond Road: That the name of Old Richmond Road located at 7095 Old Richmond Road is changed to South Cleveland Road and the following number change is made:

<u>Current</u>	<u>New</u>
7095 Old Richmond Road	1099 South Cleveland Road

- (b) Plantagenet Drive: That the name of Plantagenet Drive located at 4136 Plantagenet Drive is changed to Tropicana Drive and the following number change is made:

<u>Current</u>	<u>New</u>
4136 Plantagenet Drive	1604 Tropicana Drive

Section 3 – That this Resolution shall be effective thirty (30) days from passage.
