You must migrate any existing Oracle IaaS or PaaS instance, workload or data to a new service instance in Your Oracle PaaS and IaaS Cloud Services account within 180 days of the Cloud Services Start Date of the Cloud Services under the Cloud Services order (the "**Interim Period**"). Upon completion of this migration, You must notify Oracle via email to cloudterminations_ww@oracle.com and request that the Previous Services be terminated. If you do not provide notification, Oracle will terminate the Previous Services at the end of the Interim Period. If you do not migrate the data during the Interim Period then, at the end of the Interim Period, Your data will no longer be available to You.
