Ordinance of the Council of the Lexington Fayette Urban County Government authorizing and approving the execution and delivery of a Fifth Supplemental Lease Agreement between the Lexington Fayette Urban County Airport Board as the lessor and the Lexington Fayette Urban County Government as the lessee relating to the issuance and sale of an amount not to exceed \$65,000,000 in aggregate principal amount of Lexington Fayette Urban County Airport Board General Airport Revenue and



Revenue Refunding Bonds, 2016 Series (Lexington Fayette Urban County Government General Obligation) for the purposes of (i) financing the costs of the 2016 project to be located at the Blue Grass Airport in Fayette County, Ky. and (ii) refunding all or a portion of certain outstanding prior bonds issued by the Board received first reading.

A Resolution accepting the bid of Fristoe and Reynolds, Inc. d/b/a Comfort and Process Solutions, in the amount of \$114,500, for the HVAC Ductwork and Lighting for Coroner's Office, and authorizing the Mayor, on behalf of the Urban County Government, to execute an Agreement with Fristoe and Reynolds, Inc. d/b/a Comfort and Process Solutions related to the bid.

Upon motion by Ms. Henson, and seconded by Ms. Mossotti, the Communications from the Mayor were approved by unanimous vote and were as follows: (1) Recommending the appointment of Mr. Demario Anderson to the Bluegrass Crime Stoppers, with term expiring August 30, 2020; (2) Recommending the appointment of Ms. Sherelle Pierre, as At Large Representative, to the Board of Health, with term expiring June 30, 2018; (3) Recommending the appointment of Ms. Stephanie Theakston to the Community Action Council, filling the unexpired term of Ms. Theresa Maynard, with term expiring December 31, 2018; (4) Recommending the appointment of Mr. Jordan Parker to the Courthouse Area Design Review Board, filling the unexpired term of the Banking Representative, with term expiring June 30, 2017; and, (5)

Recommending the appointment of Mr. James Gitzinger and the reappointment of Ms. Neena Khanna to the Senior Services Commission, with terms expiring August 30, 2020.

Commander Brian Maynard, Div. of Police, presented a disciplinary recommendation regarding Officer Ray S. Wilson. It is alleged Officer Wilson has committed the offense of Unsatisfactory Performance in violation of KRS 95.450 and General Order 1973-02/I, Disciplinary Procedures, Appendix B, Operational Rules, Section 1.11 in that on various days of May and June 2016, he allegedly, over the course of a month (May 19th 2016 to June 17th, 2016), has exhibited a pattern of unsatisfactory performance in which some of his actions have placed fellow officers at unnecessary risk. May 19th, 2016: Officer Wilson was assigned as the wagon for West Sector. At 0828 hours, he was dispatched to 3660 Crosby Drive to pick up a combative prisoner and an emergency response was requested by the arresting officers. Lt. Bastian was at West Roll Call where he heard the dispatched call, heard Officer Wilson acknowledge the call, and heard him give his location from where he was responding. Shortly thereafter, Lt. Bastian left the office and made it to the scene before Officer Wilson arrived. Lt. Bastian responded without using emergency equipment and had been on scene for approximately five minutes yet Officer Wilson still had not arrived. One of the officers on scene asked the location of the wagon and Officer Wilson stated he was exiting New Circle onto Tates Creek Road. Officer Wilson ultimately advised he was on scene at 0844. May 20th, 2016: On this date, West Sector officers and Robbery/Homicide detectives investigated a murder at 892 Pinkney Drive. At 1401 hours, Officer Wilson was dispatched to Cardinal Hill Hospital to meet with detectives and another beat unit. There, officers and detectives were going to meet and formulate a plan to pick up the suspect at the CBL Plasma Center on Oxford Circle. Officer Wilson apparently never gave an arrival notification and cleared the call at 1410. An officer, two detectives, a Patrol sergeant, and Lt. Bastian ultimately made an arrest on the suspect at the plasma center. Officer Wilson never checked on the radio for clarification on his role and in his supplement, Officer Wilson indicated he went to the hospital to locate the suspect but was unsuccessful. The dispatcher gave clear radio directions to meet at the

hospital and then proceed to the plasma center to locate the suspect. June 16th, 2016: Lt. Bastian was on scene of a barricaded subject call on Deauville Drive when he contacted Sergeant Shannon to assist him with obtaining food for officers who had been on scene for over eight hours. Afterwards, Sergeant Shannon notified Lt. Bastian regarding a concern about Officer Wilson's lack of a timely response to an incident at 1600 Leestown Road where he was dispatched to assist with a disorder with a knife. Sergeant Shannon collected written statements from officers involved with the call and those statements indicated Officer Wilson was dispatched as the backup unit to the disorder involving a knife. After being dispatched, Officer Wilson waited approximately ten minutes at a restaurant on Harrodsburg & Lane Allen before attempting to respond to the call. Officer Wilson ultimately responded without emergency equipment and advised he was on the scene of the disorder approximately three minutes prior to his actual arrival. June 17th, 2016: Officer Wilson was assigned to ride bicycles in the Cardinal Valley area along with other officers. At approximately 1000 hours, Lt. Bastian was driving outbound on Versailles near Bennett where he saw a cruiser with a bicycle mounted on a trunk rack; Lt. Bastian researched the vehicle number and learned it belonged to Officer Wilson. At 1009, Lt. Bastian made a traffic stop at Versailles and Oxford, no officers responded, and he cleared the stop at 1021. At approximately 1030, Lt. Bastian was driving inbound towards Bennett and passed Officer Wilson travelling outbound on Versailles just prior to Forbes. At 1115 hours, Lt. Bastian located Officer Wilson with the other bike officers in the former Walgreen's lot at Cambridge and Versailles and observed Officer Wilson unloading his bicycle. The two other officers had their helmets on and were straddling their bicycles. In addition to the most recent documented events, Officer Wilson has received formal discipline for his job performance on two other occasions in the past three years. On November 7th, 2013, Officer Wilson received a 40-hour suspension for violation of General Order 1973-2H, Operational Rules, Section 1.48, Inappropriate Action, in relation to his handling of a theft report for a stolen firearm. Then again on February 20th, 2014, Officer Wilson received a 120-hour suspension for violation of General Order 1973-2H, Operational Rules, Section 1.48, Inappropriate Action and Section 1.11, Unsatisfactory Performance. In the second instance, there were several documented incidents of

Officer Wilson's inability to perform assigned tasks in a manner which established and maintained the highest standard of proficiency in carrying out the function and objectives of the Lexington Police Department. The appropriate punishment for this conduct is 80 hours suspension without pay.

Upon motion by Ms. Henson, and seconded by Mr. Farmer, the disciplinary recommendation was approved by majority vote (Ms. Evans was absent for the vote).
