## RESOLUTION NO. <u>280</u> - 2015

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS WITH WESTERN LITTLE LEAGUE (\$1,000.00), BLUEGRASS GIRLS SOFT PITCH (\$750.00), LEXINGTON DISTILLERY DISTRICT FOUNDATION, INC. (\$1,600.00), RARE INNERCITY MINISTRIES (\$1,450.00), LEXINGTON SISTER CITIES PROGRAM, INC. (\$1,000.00), THE COTTAGES OF LIBERTY WOODS NEIGHBORHOOD ASSOCIATION, INC. (\$500.00), AND BRIGHTON EAST HOME OWNERS ASSOCIATION, INC. (\$750.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUMS STATED.
