The Council of the Lexington-Fayette Urban County Government, Kentucky convened in regular session on April 21, 2016 at 6:00 p.m. Present were Mayor Gray in the chair presiding, and the following members of the council: Kay, Lamb, Mossotti, Scutchfield, Stinnett, Akers, Bledsoe, F. Brown, J. Brown, Farmer, Gibbs, Hensley, and Henson. Council Members Moloney and Evans were absent.

The reading of the Minutes of the previous meeting was waived.

Upon motion of Mr. Farmer, seconded by Ms. Mossotti, and approved by unanimous vote, the Minutes of the April 5, 2016 Council Meeting were approved.

Mayor Gray asked former Mayor Scotty Baesler and Ms. Lamb to join him at the podium. He spoke about the official portrait of Mr. Baesler and his time as mayor. He spoke about Mr. Baesler's professional history and about how his work as mayor affected Lexington. He spoke about the work of Ms. Lamb and historian Mr. Foster Ockerman, Jr.

Ms. Lamb thanked Mr. Ockerman, the Lexington History Museum Board, the artist Mr. Steve Sawyer, Mayor Baesler and others who came to celebrate the portrait. She spoke about how the project came to fruition. She also spoke about how the funding was raised for the mayoral portrait project and the future portraits that will be completed.

Mayor Baesler spoke about his time as mayor and about the importance of a mayor's relationship with Council. He thanked everyone for the honor and commended the Council on their great work.

Mayor Gray asked Ms. Akers and Mr. Amin Omidy to join him at the podium. Mayor Gray spoke about the landscape architecture profession and how landscape architects are promoting their field. Mayor Gray read a proclamation honoring landscape architecture and proclaiming April 2016 Landscape Architecture Month in Lexington.

Ms. Akers thanked Ms. Beth Workman, one of her constituents, for her work on raising awareness of Landscape Architecture Month. She spoke about the landscape architecture profession and examples of landscape architecture in Lexington.

Mr. Omidy, President of the Ky. Chapter of the American Society of Landscape Architects (ASLA), thanked everyone for the recognition of this profession. He spoke about the power of landscapes and about how landscape architecture affects wellness and health. He introduced Mr. John Swintosky, Kentucky ASLA Chapter Trustee.

Mr. Swintosky thanked Mayor Gray and Council for this recognition. He recognized the landscape architects in the Lexington community in all facets of the profession, as well as the landscape architecture program at the University of Ky.

Mayor Gray asked Ms. Bledsoe to join him at the podium as well as Mr. Sam Newman, a Tates Creek High School student. Mayor Gray spoke about Junior Achievement of the Bluegrass and its effect on students. He spoke about the Jr. Apprentice Competition and that Mr. Hensley participated as a judge. Mayor Gray congratulated students from Tates Creek High School for winning the competition with their creation of the Bristle Broom, an invention created for the competition. Mayor Gray read a proclamation commemorating the success of the Tates Creek High School team and declaring Thursday, April 21, 2016 as Bluegrass Apprentice Day in Lexington.

Ms. Bledsoe spoke about Jr. Achievement and the competition. She indicated Mr. Newman brought his invention for the Council to see.

Mr. Newman described and demonstrated his invention. He spoke about the recycled parts that comprised the invention and the cost of the product.

Commander Guy Greene, Div. of Police, presented a police disciplinary item regarding Officer Steven McCane.

It is alleged that Officer Steven E. McCane has committed the offense of Unsatisfactory Performance in violation of KRS 95.450 and General Order 1973-02/1 -Disciplinary Procedures, Appendix B, Operational Rule 1.11 in that on various days of 2006 through 2016 he allegedly has had a total of eleven (11) infractions of the rules pertaining to at fault collisions since 2006 and he has repeatedly failed to operate his vehicle at all times in such a manner as to not be at fault in collisions. Officer McCane's first at fault collision was in 2006, followed by two (2) at fault collisions in 2008, one (1) at fault collision in 2009, two (2) at fault collisions in 2012, one (1) at fault collision in 2013, three (3) at fault collisions in 2015 and, most recently he was involved in an at fault collision on Wednesday, March 16, 2016. Officer McCane was provided with a written reprimand and an 80-hour suspension of his home fleet privileges on September 23, 2013 for his first infraction of violating General Order 73-2/H, Operational Rules, Section 1.40, At-Fault Collisions. On February 5, 2016, Officer McCane was suspended for ten (10) hours and received a 160-hour home fleet suspension for his second violation of General Order 1973-02/I - Operational Rules, Section 1.40, At-Fault Collisions. The most recent collision, on March 16, 2016, means Officer McCane would be in violation of Section 1.40, At-Fault Collisions for the third time in his career with the Lexington Police Department. The recommended discipline is Forty (40) Hours Suspension (One (1) Work Week) Without Pay and Six (6) Months Home Fleet Suspension (Officer McCane must request re-instatement.)

Upon motion by Mr. Farmer, and seconded by Ms. Akers, the disciplinary recommendation was approved by majority vote, (Mr. F. Brown and Mr. Hensley were absent for the vote.)

Assistant Chief Christofer Sweat, Div. of Fire and Emergency Services, presented a fire disciplinary matter for Firefighter Joshua Day.

It is alleged that Firefighter Joshua Day has committed the offense of AWOL 1st Offense, a violation of UDG 1.11 as supported by POL 100.09 and in violation of KRS

95.450 in that on the 26th day of March 2016, he allegedly committed offenses outlined in IA Case 2016-AWOL-0004, reviewed by the Fire Chief on April 11, 2016. The recommended discipline is a Written Reprimand.
