AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF ENGINEERING TECHNICIAN, GRADE 514N, ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF ASSOCIATE MUNICIPAL ENGINEER, GRADE 519E, ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF PROGRAM SPECIALIST, GRADE 513E, AND ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF EQUIPMENT OPERATOR, GRADE 510N, CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF SLM ASSISTANT SUPERINTENDENT, GRADE 520E, ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF ENGINEERING TECHNICIAN PRINCIPAL, GRADE 518E, ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF PUBLIC SERVICE SUPERVISOR, GRADE 514N, AND ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF MAINTENANCE MECHANIC, GRADE 515N, AND CHANGING THE PAY GRADE OF ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF SLM SUPERINTENDENT, FROM GRADE 520E TO 521E AND REALLOCATING THE INCUMBENT, ALL IN THE DIVISION OF WATER QUALITY, AND APPROPRIATING FUNDS PURSUANT TO SCHEDULE NO. 0055.
