#### **PURCHASE OF SERVICE AGREEMENT**

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the \_\_\_\_th day of August, 2024, by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and, NAMI LEXINGTON with offices located 498 Georgetown Street, Suite 100, Lexington, Kentucky 40508, (hereinafter "Organization").

#### WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

- This Agreement shall include the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:
  - A. Exhibit A RFP #21-2021
  - B. Exhibit B Organization's Response to RFP #20-2024
- 2. Government hereby retains Organization for the period beginning on **July 1**, **2024**, and continuing for a period of two (2) years from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.
- 3. Government shall pay Organization the sum of **Eighty Thousand 00/100 Dollars** (\$80,000) for Fiscal Year 2025 and **Eighty Thousand 00/100 Dollars** (\$80,000) for Fiscal Year 2026 for the services required by this Agreement, said services being more particularly described in Exhibits A and B, one-fourth (1/4th) of which shall be payable in

September 2024 or shortly thereafter upon receipt of an **invoice** (for July through December 2024), with one-eighth (1/8<sup>th</sup>) payable each quarter thereafter upon submission of a quarterly invoice and a detailed quarterly program report. **Quarterly invoices and detailed program reports shall be submitted by January 17<sup>th</sup>, 2025, April 18<sup>th</sup>, 2025, July 25<sup>th</sup>, 2025, <b>October 17<sup>th</sup>, 2025, January 16<sup>th</sup>, 2026, and April 17<sup>th</sup>, 2026.** A two-year-end program report shall be submitted by July 24<sup>th</sup>, 2026. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

- 4. In the event of termination of this Agreement by Government as provided for in paragraph 2 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.
- 5. Organization shall perform all duties and services included in Exhibits attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in Exhibits A and Band for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and
- 6. Organization shall indemnify, defend and hold harmless Government, its elected and appointed officials, employees, agents, volunteers, and successors in interest, from and against any and all liability, damages, and losses, including but not limited to: demands, claims, liens, suits, notices of violation from governmental agencies, obligations,

causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Organization's performance of or breach of this Agreement and/or the provision of goods or services, provided that (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Organization; and (b) not caused solely by willful misconduct of the Government. The Parties understand and agree that the Organization's obligation to defend the Government includes the obligation to investigate, handle, respond to, resist, provide a defense for, and defend claims, at Organization's expense, using attorneys approved in writing by the Government, which approval shall not be unreasonably withheld. The Parties also understand and agree that the Organization's obligation to indemnify includes, but is not limited to: attorney fees and expenses, costs of litigation, court and administrative costs, expert witness fees and expenses, judgments, fines, penalties, interest, all environmental cleanups and remediation costs of whatever kind, and any liability arising from death, injury, or damage of any kind, to any person, including employees and agents of Organization and Government, and damage to, or destruction of, any property, including the property of Government. This provision shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this Agreement. Organization understands that Government is a political subdivision of the Commonwealth of Kentucky and acknowledges and agrees that the Government is unable to provide indemnity or otherwise save, hold harmless, or defend the Organization in any manner.

7. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not

become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.

- 8. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in Exhibits A & B attached hereto.
- 9. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.
- 10. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

- 11. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.
- 12. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.
- 13. This instrument, and additional documents attached hereto, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.
- 14. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:
  - A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
  - B. Investment Funds Management: The governing board may elect to either:
    - (1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or

(2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

- C. Investment Policies - Safety and Prudence.
  - (1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

- (2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.
- (3) All investments shall be reviewed monthly by a finance or investment committee of the agency.
- (4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.
- D. Audit - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

# Lexington-Fayette Urban County Government

#### Request for Proposals

The Lexington-Fayette Urban County Government hereby requests proposals for #21-2024 Mental Health – Extended Social Resources (ESR) Grant Program to be provided in accordance with terms, conditions and specifications established herein.

Sealed proposals will be received through Ion Wave until **2:00 PM**, prevailing local time, on **April 25, 2024**. All forms and information requested in RFP #21-2024 must be included and attached in Response Attachments tab in Ion Wave.

Proposals received after the date and time set for opening proposals will not be accepted. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted in lon Wave before the date and time set for opening proposals.

Proposals, once submitted, may not be withdrawn for a period of one hundred twenty (120) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Signature of this proposal by the Proposer constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

The Lexington-Fayette Urban County Government encourages the participation of minority- and women-owned businesses in Lexington-Fayette Urban County Government contracts. This proposal is subject to Affirmative Action requirements attached hereto.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

#### Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

#### **Equal Employment Opportunity**

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, religion, sex (including pregnancy, sexual orientation or gender identity), national origin, disability, age, genetic information, political affiliation, or veteran status, and to promote equal employment through a positive, continuing program from itself and each of its sub-contracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

#### **Kentucky Equal Employment Opportunity Act**

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;
- (3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and
- (4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers'

representative of the contractor's commitments under the nondiscrimination clauses."

#### The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

- (1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.
- (2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.
- (3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as <a href="mailto:special conditions">special conditions</a> in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available work-force in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

#### **LFUCG Non-Appropriation Clause**

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

#### **Contention Process**

Vendors who respond to this invitation have the right to file a notice of contention associated with the RFP process or to file a notice of appeal of the recommendation made by the Director of Procurement resulting from this invitation.

Notice of contention with the RFP process must be filed within 3 business days of the bid/proposal opening by (1) sending a written notice, including sufficient documentation to support contention, to the Director of the Division of Procurement or (2) submitting a written request for a meeting with the Director of Procurement to explain his/her

contention with the RFP process. After consulting with the Commissioner of Finance the Chief Administrative Officer and reviewing the documentation and/or hearing the vendor, the Director of Procurement shall promptly respond in writing findings as to the compliance with RFP processes. If, based on this review, a RFP process irregularity is deemed to have occurred the Director of Procurement will consult with the Commissioner of Finance, the Chief Administrative Officer and the Department of Law as to the appropriate remedy.

Notice of appeal of a RFP recommendation must be filed within 3 business days of the RFP recommendation by (1) sending a written notice, including sufficient documentation to support appeal, to the Director, Division of Procurement or (2) submitting a written request for a meeting with the Director of Procurement to explain his appeal. After reviewing the documentation and/or hearing the vendor and consulting with the Commissioner of Finance and the Chief Administrative Officer, the Director of Procurement shall in writing, affirm or withdraw the recommendation.

#### **EQUAL OPPORTUNITY AGREEMENT**

#### Standard Title VI Assurance

The Lexington Fayette-Urban County Government, (hereinafter referred to as the "Recipient") hereby agrees that as a condition to receiving any Federal financial assistance from the U.S. Department of Transportation, it will comply with Title VI of the Civil Rights Act of 1964, 78Stat.252, 42 U.S.C. 2000d-4 (hereinafter referred to as the "Act"), and all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, (49 CFR, Part 21) Nondiscrimination in Federally Assisted Program of the Department of Transportation – Effectuation of Title VI of the Civil Rights Act of 1964 (hereinafter referred to as the "Regulations") and other pertinent directives, no person in the United States shall, on the grounds of race, color, national origin, sex, age (over 40), religion, sexual orientation, gender identity, veteran status, or disability be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which the Recipient receives Federal financial assistance from the U.S. Department of Transportation, including the Federal Highway Administration, and hereby gives assurance that will promptly take any necessary measures to effectuate this agreement. This assurance is required by subsection 21.7(a) (1) of the Regulations.

#### The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

The Contractor will not discriminate against any employee or applicant for employment because of physical or mental handicap.

- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment Opportunity, states:

The Secretary of Labor may investigate the employment practices of any Government contractor or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have been violated.

The Lexington-Fayette Urban County Government practices Equal Opportunity in recruiting, hiring and promoting. It is the Government's intent to affirmatively provide employment opportunities for those individuals who have previously not been allowed to enter into the mainstream of society. Because of its importance to the local Government, this policy carries the full endorsement of the Mayor, Commissioners, Directors and all supervisory personnel. In following this commitment to Equal Employment Opportunity and because the Government is the benefactor of the Federal funds, it is both against the Urban County Government policy and illegal for the Government to let contracts to companies which knowingly or unknowingly practice discrimination in their employment practices. #### 1.0 GENERAL INFORMATION & SCOPE

#### 1.1 Background

Each fiscal year the Mayor and Urban County Council allocate funds for use by selected 501(c)(3) non-profit partner agencies through the Department of Social Services' Extended Social Resource (ESR) Program.

The LFUCG is accepting applications from qualified non-governmental, non-profit agencies with current **501(c)3** tax exempt status and with a physical business or program site location in Fayette County (hereinafter, referred to as "Applicant") for ESR funding for FY2025 & 2026 (July 1, 2024 – June 30, 2026). This funding is intended to support agency **programs** which respond to the **funding priorities** established herein. **THIS FUNDING IS <u>NOT</u> INTENDED TO SUPPORT GENERAL AGENCY OPERATIONS, other than overhead required to support the subject program.**

Completed proposals must be submitted **no later than 2:00 PM on Thursday, April 25<sup>th</sup>, 2024,** and late or incomplete proposals will not be accepted or evaluated.

The LFUCG intends to conduct proposal evaluation in April and May 2024 immediately following the proposal due date, with the intention to make funding announcements approximately in late May, 2024. This timeline is subject to change without notice.

In 2022-23 NAMI reports there are 746,000 adults in KY who report mental health concerns, 189,000 with Serious Mental Illness, 43.6% report anxiety and depression, 232,00 receive no treatment and 40.9% cited access and affordability as barriers. Overdose deaths from fentanyl and methamphetamine continue to be high and overdoses in the African American community are rising; from 172 in 2020 to 252 in 2022. Affordable housing is a community hurdle. 2023 Homelessness counts range from 818 (LexCount) to 2419 (Catholic Action count), 1000 students experienced 'displacement' with 450 being declared without stable housing. Last year our PS Warmline calls increased by 68%, office calls 50% and a 30% increase in calls from parents worried about children's mental health. Suicidal ideation, gun violence and trauma all add a toll on mental health and community wellbeing.

The disparities among minority communities in underserved areas such as Serious Mental Illness (SMI) and Substance Use Disorders (SUD) are more fragile and extreme than ever. The system fails our most vulnerable. The 2020 Mayor's Commission for Racial Justice & Equality described discrimination, language, cultural, access, poor experiences and trust barriers as roots of these disparities.

Participation Station (PS) is a no barrier program where people can recover alongside their peers. The program is almost completely peer to peer. All services are free of charge, referrals are unnecessary. Peer System navigators empower participants and assist them in navigating challenging systems of care, including benefits, insurance, housing, transportation and other high barrier systemic programs.

#### 5.1.2 Service Delivery Model

Participation Station provides a personal, trusted environment for mental health and substance use care, offering a variety of direct services designed to empower and assist folks as they 'recover through' SMI and SUD.

- 1. System Navigators Empower participants, identifying barriers and issues interfering with their recovery. Provide direct assistance with areas of housing, food, GED, mental and physical health treatment, legal issues, discrimination, and addiction supports. Our Multicultural Action Team (MAC) provides increased outreach, education, and activity engagement with minority communities.
- 2. Evidence Based Support Groups Emotions Anonymous, NAMI Connections, Double Trouble in Recovery (DTR) for co-occurring SMI/SUD, Life in Balance, Schizophrenia Alliance and LGBTQ+ are held weekly at PS including weekend offerings.
- 3. Educational Tracks Five 45-minute groups are held daily, Monday-Friday. Based on the Boston University Psychiatric Rehabilitation Model for recovery, these groups give both teachers and participants (all peers) a sense of meaning and purpose as they build knowledge and skills.
- 4. The Warmline Evidence based telephonic peer support and SMI/SUD resource line offered 1-4p.m. Monday Friday and 5-9p.m. Monday Saturday. Provides support during isolation, a listening ear during times of vulnerability.

  5. PS is a place for Community partners to interact with their clients in a familiar setting. Case management, therapy and
- medication management are typically provided. PS provides inherent social components, daily structure and routine; valuable recovery supports. Program participation has led to employment, self-direction, sufficiency and home ownership! Participants become productive, engaged citizens with sustainable recovery connections.

#### **5.1.3 Client Eligibility and Requirements**

Individuals with SMI/SUD can be slow to develop trust due to past trauma, symptoms and experiences. This tendency is widespread and can be pronounced in minority participants. This is a barrier to taking part in treatment. This reality was shown throughout the report from the 2020 Mayor's Commission for Racial Justice & Equality. Participation Station leadership incorporates skills in developing trust and culturally competent, sensitive interventions with all participants. The program philosophy directs that there are no formal eligibility requirements for services (no barrier). All services are free and open to any adult in Fayette County.

Participants must agree to abide by the basic rules of the program, treating others with respect, no drug or alcohol use at the program, and no threats or physical violence. This has allowed the program to be accessible and open to individuals who were perhaps too ill or intimidated to function in other more traditional programs. We have found that when participants do not have to participate in any particular program and are able to "take their time", they invariably become involved because of the supportive environment and the innate desire to recover.

Individuals teaching tracks at the program agree to volunteer an hour for each track they are paid a stipend to teach. We have found that "getting a check", has done wonders in improving self-esteem and self-image for individuals with little or no successful work history. Their sense of empowerment improves their self-esteem.

#### 5.1.4 Evidence-Based/Best Practice

The Center for Medicare/Medicaid Services (CMS) states, 'Peer support services are an evidence-based mental health model consisting of a qualified peer support provider assisting individuals with their recovery from mental illness and substance use disorders'. CMS recognizes that the experiences of peer support providers, as consumers of mental health and substance use services, are an integral part in the delivery of effective treatment.' SAMHSA states 'Research has shown that peer support facilitates recovery and reduces health care costs. Peers also provide assistance that promotes a sense of belonging within their community. The ability to contribute to and enjoy one's specific community is key to recovery and well-being. Another critical component that peers provide is the development of self-efficacy and empowerment through role modeling and assisting peers with ongoing recovery through mastery of experiences and finding meaning, purpose, and social connections in their lives.'

Participation Station uses the Substance Abuse and Mental Health Services Administration (SAMHSA) toolkit for Consumer Operated Services to assure that the array of services offered are all evidence-based best practices. The Wellness Recovery Action Plan (WRAP) – an evidence-based practice for relapse prevention is a notable example of services offered. The Fidelity Assessment Common Ingredients Tool (FACIT) is administered annually to assure fidelity with the Peer Support Evidence-Based Practice model. Additionally, the leaders at Participation Station use the Psychiatric Rehabilitation model from the Boston University Center of Rehabilitation and Recovery as the model for educational/recovery programming. This model is the pre-eminent source of recovery programming in the country.

#### 5.2 Program Measures & Evaluation

#### **5.2.1 Service Efficacy & Desired Outcomes**

"A process of change through which individuals improve their health and wellness, live a self-directed life, and strive to reach their full potential." This is the definition of Recovery provided by the Substance Abuse and Mental Health Services Administration (SAMHSA) and the philosophy behind PS. Our peer support program strives to walk beside individuals in their recovery journey by offering information, support, lived experience and hope from their own recovery. Measurement of desired outcomes is completed employing the participant's own perception of their recovery. Overall program outcomes are measured using the Peer Outcomes Protocol® which is a well-researched and reliable tool for assessing peer support outcomes. This is done quarterly with a 100% sample of voluntary participants attending and taking part in the survey during a randomly selected week.

Attending educational or support groups, assistance with 'Navigation'- Social Security issues/information regarding community resources, helping prepare for the GED, or calling the Warmline are each considered individual services. Participant perception surveys are collected following education and life-skills tracks, warmline calls, and system navigation services. The individual is not, however, discontinued or "graduated" from the program - they may stay as long as they choose. Many of our participants attend regularly, and then "check in" periodically for any needed support or to socialize. The philosophy of the program is that recovery is not a linear trajectory but is instead an established, ongoing, supportive Eco-System, rooted in experiences that help an individual live a healthier, fulfilling life of their choice.

#### 5.2.2 Client Empowerment & Community Impact

This education and supports-based model focuses on four human skill areas of Living, Learning, Working/Productivity, and Socialization/Support; individuals with SMI/SUD engage with Peer Support Specialists in actively defining, learning, developing, and practicing vital, real-life skills to enhance their recovery. This approach provides a uniquely empowering springboard of self-directed opportunities to return to productive, healthy, and most importantly, meaningful lives and goals of their choosing. In data from our Peer Outcomes Protocol surveys, an overwhelming majority (78%) believed that the goals they had in traditional treatment programs were really the goals of their therapists/counselors/physicians. They identified this as a very specific reason for many failed prior attempts at recovery. Many were never asked about what they wanted or needed in their life.

Our participants' self-determined goals have included: healing past trauma, maintaining sobriety, getting a job, improving their relationship with their family, getting their children back, learning parenting skills, learning how to budget, learning how to deal with stress, learning more about their diagnosis, buying a car, living independently, having healthy friendships, re-establishing a Faith Community, getting a GED, and improving their mental and physical health. The most important change we see in individuals is when they acquire HOPE, PURPOSE and BELIEF in their own power to change and manage life around their illness or addiction. The Community benefits whenever citizens are healthy contributors and co-creators of positive initiatives. Resources are saved and lives are not lost in dismal statistics and systemic recidivism.

#### 5.2.3 Data Assessment & Quality Improvement

Participation Station strives to assist participants in any area of their lives where they may be struggling, rather than just focusing on reducing symptom load. This list includes healthcare, therapy, stable housing, food security, employment, etc. Our program indicators measure the desired outcomes of greater self-reliance and evidence of progress toward recovery to assure the program's accountability and effectiveness. Data is analyzed for programmatic outcomes measured by number of services provided, while outcomes for the participants are measured through the Peer Outcomes Protocol surveys, an evidence-based assessment of functioning. In 2023, our participants received 3521 "assists" from our System Navigators alone. These numbers fail to include the informal peer support that occurs routinely as participants provide peer support to each other naturally within the confines of the program day!

All data is analyzed for any trends or patterns, any significant variation, or the need to further explore the data. Participation Station's Leadership Team meets twice monthly to address scheduling and program issues. These meetings include analyzing program data and making decisions regarding any needed change. Our data has been utilized consistently by the Leadership Team to: 1. Increase outreach during the pandemic, 2. Provide additional resources to the homeless population, 3. Increase number of community partners and 4. Develop a local resource guide that covers all areas of expressed need. The Leadership team receives coaching from our PS Program Advisor who previously served as the Performance Improvement Director at Eastern State Hospital.

Participation Station's experienced and long-tenured staff (average tenure 8.9 years) identify as having lived experience with mental illness and /or substance use disorder; are certified Adult Peer Support Specialists in recovery for a minimum of two years, demonstrate a thorough knowledge of techniques to promote recovery in peers. They exhibit a high degree of cultural competence working with diverse groups of participants, providers, and stakeholders of mental health/substance use services with dignity, respect, and compassion.

Program Director - Administrative management, Community liaison, Personnel supervision, and Policy and Financial oversight.

Multi-Cultural Action Committee Chair – African American Community liaison, Veteran, NAMI Signature programs trainer, Court Appointed Special Advocates volunteer, Eastern State Hospital Peer Support Team Coordinator, Fayette Mental Health Court family services Coordinator.

Program/Training Coordinator - Implement, coordinate and evaluate programming; elicit feedback and input from participants, providers, and stakeholders; provide oversight of staff conduct, facilitate conflict resolution, training and continuing education.

Environmental Coordinator - Supervises client participation in facility cleanliness and safety while providing skills training for participants.

System Navigators (3)- assist individuals with food, housing, education/GED, mental & physical health issues, legal issues, addiction recovery supports, legal concerns, and any issue that helped by accessing community resources. Warmline Operators – team of 8 peer specialists who provided telephonic peer support with high degree of compassion

PS has formal agreements and working relationships, sharing resources with and from existing and new community partners, including but ever evolving: Justice-oriented partners, Domestic Violence / Rape Crisis centers, Health, Behavioral Health and SUD providers / Hospitals, The Faith Community, Homelessness and Housing organizations, Food security partners, Employment services, Government agencies, Police, FCDC, Universities / Colleges / Career Centers, Carnegie Center, OWL, Recovery Café, Voices of Hope, Vocational Rehab, Catholic Action Center, God's Pantry, The Well, Natalie's Sisters, Fayette Mental Health Court, Eastern State Hospital, New Vista, UK, EKU, Asbury, etc.)

NAMI Lexington's volunteer board members, all uniquely qualified by their lived-experience, co-create and empower implementation of all our programming including PS. Volunteers are the lifeblood of all our programs, events, and activities, providing over 33,000 hours of service annually.

PS contracts with Eastern State Hospital to provide daily support groups and educational classes.

PS contracts with the KY Department of Behavioral Health to expand Peer-operated services in Kentucky. PS contracts with New Vista for program evaluation.

NAMI Lexington provides program advocacy, evaluation, and quality improvement services, sustainability planning, fiscal and reporting oversight, administrative and payroll services, and numerous opportunities for PS participants to attend public advocacy and educational events.
