## **TEMPORARY CONSTRUCTION EASEMENT**

This **TEMPORARY CONSTRUCTION EASEMENT** is made and entered into this the <u>lo</u> day of <u>Aprilo</u>, 2017, by and between **YITZCHAK Y. KURS, a single person**, P.O. Box 8265, Lexington, Kentucky 40533, which is the in-care of tax mailing address for the current year ("Grantor"), and **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

## WITNESSETH:

That for and in consideration of the sum of FOUR THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS AND 00/100 (\$4,375.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantor has BARGAINED and SOLD and does hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Temporary Construction Easement (a portion of 600 Sheridan Drive)

Clays Mill Road Improvement Project, Section 1 (Harrodsburg Road to New Circle Road) Parcel No. 75

Being a tract of land lying in Fayette County on the west side of Clays Mill Road, point of beginning being approximately 143 feet south of the intersection of Sheridan Drive and Clays Mill Road, and more particularly described as follows:

The above described parcel contains 0.045 acres (1,950 sq. ft.) of temporary construction easement;

Being a portion of the same property conveyed to Yitzchak Y. Kurs, a single person, by deed dated March 5, 2010 of record in Deed Book 2931, Page 583 in the Fayette County Clerk's Office:

TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of

the Grantor. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon completion of the project.

Grantor does hereby release and relinquish unto the Grantee, its successors and assigns forever, all of his right, title, and interest in and to the property to the extent of the interest conveyed herein, including all exemptions allowed by law, and does hereby covenant to and with the Grantee, its successors and assigns forever, that he is lawfully seized in fee simple of said property and have good right to sell and convey the same as herein done, and that he will **WARRANT GENERALLY** said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS 382.135(2)(c), this temporary construction easement, which pertains to a public right-of-way, need not contain a statement of consideration.
