AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY TRANSFERRING ONE (1) CLASSIFIED POSITION OF HUMAN RESOURCES ANALYST, GRADE 521E, FROM THE DIVISION OF WASTE MANAGEMENT TO THE DIVISION OF HUMAN RESOURCES, AND TRANSFERRING THE INCUMBENT; TRANSFERRING ONE (1) UNCLASSIFIED POSITION OF PROGRAM COORDINATOR, GRADE 525E, FROM THE OFFICE OF THE MAYOR TO THE DEPARTMENT OF SOCIAL SERVICES; TRANSFERRING THREE (3) CLASSIFIED POSITIONS OF LANGUAGE ACCESS SPECIALIST, GRADE 523E, FROM THE OFFICE OF THE MAYOR TO THE DEPARTMENT OF SOCIAL SERVICES, AND TRANSFERRING THE INCUMBENTS; AND TRANSFERRING ONE (1) CLASSIFIED POSITION OF ADMINISTRATIVE SPECIALIST SENIOR, GRADE 516N, FROM THE OFFICE OF THE MAYOR TO THE DEPARTMENT OF SOCIAL SERVICES, AND TRANSFERRING THE INCUMBENT, ALL EFFECTIVE AS OF JULY 1, 2025.
