

JUSTIFICATION FOR SOLE SOURCE CERTIFICATION

Sole Source Purchases are defined clearly, based upon a legitimate need, and are limited to a <u>single</u> <u>supplier</u>. Sole source purchases are normally not allowed except when based upon strong technological grounds such as operational compatibility with existing equipment and related parts or upon a clearly unique and/or cost effective feature requirement. The use of sole source purchases must be justified and shall be limited only to those specific instances in which compatibility or technical performance needs are being satisfied.

Sole Source Services are defined as a service provider providing technical expertise of such a unique nature that the service provider is clearly and justifiably the only practicable source available to provide the service. The justification shall be based on the uniqueness of the service, sole availability at the location required, or warranty or defect correction service obligations of the service provider.

This form must be filled out for the request to purchase any good or non-professional service that requires a competitive procurement process (informal quotes (\$2,500-\$10,000), formal quotes (\$10,001 - \$29,999.99), or formal bid (\$30,000 or more) as defined in the LFUCG's Purchasing Manual. This form must be completed in its entirety and attached to the purchase requisition.

Note: Sole Source Purchase requests for goods exceeding \$30,000 will require approval by the Urban County Council by submitting an Administrative Review Form. A copy of this form must be signed off by Central Purchasing and attached to the Administrative Review Form.

It is the invention of Tyler Miller and licensed exclusively to Miller Mendel, Inc (Miller's company). eSoph provides our Backgrounds unit inventive functionality of electronic reference checks, including ability to view aspects of the applicant's history, and whether the applicant has been entered into eSOPH before. Only one vendor sells this software.

Internet searches were conducted by the Backgrounds unit and yielded no viable alternatives for a software that performed the same functions as eSOPH. The Backgrounds Unit also reached out to other police agencies to inquire about backgrounds investigations software and again, no other viable alternatives were found.

<u>Cost comparisons are not available since this is a standalone product. However, checking in with other police agencies using eSOPH, the quoted cost is appropriate as compared to costs paid by others using the software.</u>

Current, LPD is seeking to hire 2-3 police recruit classes per year to sustain the number of officers needed to adequately fulfill the department's responsibilities and mission. Our backgrounds investigators have a great responsibility to adequately investigate every applicant to the police department because harm could come on the department and LFUCG as a whole if they are not diligent in this process. LPD seeks to hire applicants who demonstrate the highest level of integrity and display the strongest of character. The former process of background investigations required immense manpower. 10-12 background investigators were necessary, pulled from their normal assignments to assist. This compounds the department-wide staffing shortages. Due to the services and capabilities of the eSOPH software, the number of required backgrounds investigators is greatly reduced. This improves efficiency, puts less strain on staffing needs, and reduces the potential of overtime expenses as the investigators complete the backgrounds process.
