

RESOLUTION NO. 576 - 2025

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS RELATED TO COUNCIL CAPITAL PROJECT EXPENDITURE FUNDS WITH LFUCG DIVISION OF TRAFFIC ENGINEERING (\$30,000.00); LFUCG DIVISION OF ENVIRONMENTAL SERVICES (\$15,000.00); LFUCG DIVISION OF ENVIRONMENTAL SERVICES (\$632.00); GARDEN MEADOWS HOMEOWNERS ASSOCIATION, INC. (\$1,500.00); VOICES OF HOPE- LEXINGTON, INC. (\$1,381.96); THE HOPE CENTER, INC. (\$850.00); LFUCG DIVISION OF TRAFFIC ENGINEERING (\$9,000.00); LFUCG DIVISION OF PARKS AND RECREATION (\$30,000.00); AND LFUCG DIVISION OF ENVIRONMENTAL SERVICES (\$2,574.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUM STATED.

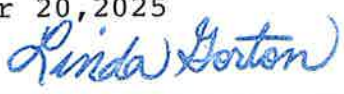
BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute agreements related to Council Capital Project Expenditure Funds, which is attached hereto and incorporated herein by reference, with LFUCG Division Of Traffic Engineering, LFUCG Division Of Environmental Services, Garden Meadows Homeowners Association, Inc., Voices Of Hope- Lexington, Inc., The Hope Center, Inc., LFUCG Division Of Traffic Engineering, and LFUCG Division Of Parks And Recreation, for the Office of the Urban County Council.

Section 2 – That an amount, not to exceed the sum stated, be and hereby is approved for payment or transfer to LFUCG Division Of Traffic Engineering (\$30,000.00); LFUCG Division Of Environmental Services (\$15,000.00); LFUCG Division Of Environmental Services (\$632.00); Garden Meadows Homeowners Association, Inc. (\$1,500.00); Voices Of Hope- Lexington, Inc. (\$1,381.96); The Hope Center, Inc. (\$850.00); LFUCG Division Of Traffic Engineering (\$9,000.00); LFUCG Division Of Parks And Recreation (\$30,000.00); and LFUCG Division Of Environmental Services (\$2,574.00), from account #1105-121002-91715, from various Council Districts, pursuant to the terms of the Agreements.

Section 3 – That this Resolution shall become effective on the date of its passage.
