#### B. General Terms

#### Commencement Date

All program ficenses and the period of performance for all services are effective upon shipment of tangible media or upon the effective date of this ordering document if shipment of tangible media is not required.

### 2. Fees, Invoicing, and Payment Obligation

- All fees due under this ordering document shall be due and payable net 30 days from the date of invoice, and shall be non-cancellable and the sums
