WHEREAS, the GOVERNMENT and FCAO further agreed to allow FCAO to design and construct a new paved driving pad on the undeveloped southeast section of the Old Frankfort Pike Landfill and upon completion of the new paved driving pad FCAO would allow the GOVERNMENT use to train drivers of government vehicles;

WHEREAS, pursuant to Section II of the Agreement, the parties wish to exercise their right to extend the terms of the Agreement;

NOW, THEREFORE, in consideration of the foregoing and mutually agreed upon promises, conditions, and covenants hereinafter set forth, the parties hereto agree as follows:

- 1. That the above recitals are incorporated herein by reference as if fully stated.
- 2. The terms of the Agreement shall be extended until December 31, 2018, the last day of the current elected term of Fayette County Attorney, Larry S. Roberts.
- 3. In the event of a conflict between the terms of this Amendment and the terms of the Agreement, this Amendment shall control. All other terms and conditions of the Agreement shall remain unchanged and in full force and effect as stated in the Agreement.
