

**Memorandum of Understanding
Between
Lexington-Fayette Urban County Government
And**

Lexington-Fayette County Health Department

I. General:

This Memorandum of Understanding (MOU) sets forth the terms between the Lexington-Fayette County Health Department and the Lexington-Fayette Urban County Government to provide substance treatment referrals for clients utilizing the Needle Exchange Program located at the Lexington-Fayette County Health Department.

II. Background:

The Lexington-Fayette County Health Department operates a Needle Exchange Program (NEP) on Fridays from 1:30 p.m. to 4:00 p.m. An important component of the program is providing substance abuse treatment referrals for clients who utilize the needle exchange program seeking treatment.

Since its inception, Needle Exchange Program staff has used a resource guide to provide information to clients who are seeking substance abuse treatment.

In an effort to provide requested information on available substance abuse treatment services, the Lexington-Fayette County Health Department would like to partner with Lexington-Fayette Urban County Government to provide substance abuse treatment referrals during the Needle Exchange Program.

III. Purpose:

This MOU will outline the goal of the partnership between Lexington-Fayette Urban County Government and Lexington-Fayette County Health Department to provide substance abuse treatment referrals to Needle Exchange Program participants.

IV. Responsibilities:

Lexington-Fayette County Health Department will:

1. Operate the Needle Exchange Program each Friday from 1:30p.m. to 4:00 p.m. at the Lexington-Fayette County Health Department located at 650 Newtown Pike, Lexington, KY 40508.
2. Needle Exchange staff will refer program participants who are interested in substance abuse treatment to the substance abuse program coordinator for possible program referral.
3. The Lexington-Fayette County Health Department will provide the substance abuse coordinator with office space, a computer, a telephone and an identification badge for building access.
4. Lexington-Fayette County Health Department will provide paper copies of compiled substance abuse treatment resources to clients in the absence of the Substance Abuse Coordinator.

Lexington-Fayette Urban County Government will:

1. Lexington-Fayette Urban County Government's Department of Social Services Substance Abuse and Violence Intervention (SAVI) Program will provide a substance abuse program coordinator to provide substance abuse treatment information to needle exchange program clients who are seeking treatment from 1:30 p.m. to 3:30 p.m. each Friday the Needle Exchange Program is in operation at the Lexington-Fayette County Health Department location.
2. The Substance Abuse Coordinator will provide the Needle Exchange Program staff with an overview/training on how to locate substance abuse treatment programming (this overview will allow program staff to provide substance abuse treatment referrals in the absence of the substance abuse coordinator).
3. The Substance Abuse Coordinator will provide as much notice as possible to the Needle Exchange Program Manager when he/she is unable to attend the NEP due to vacation, illness or scheduling conflict.

V. Reporting:

To protect client anonymity, only demographic information will be collected on clients who request referral to substance abuse treatment services. The collected information will be used to document the number of substance abuse treatment referrals made. This non-identifying information will be used to reports the number of referrals made only.

VI. HIPAA:

Lexington-Fayette Urban County Government's Department of Social Services Substance Abuse and Violence Intervention (SAVI) Program will:

1. Not use or disclose client protected health information (PHI) other than as permitted by the Lexington-Fayette County Health Department and in accordance with rules and regulations set for by the Department for Health & Human Services (HHS) and the Health Insurance Privacy & Accountability Act (HIPAA).
2. Appropriate safeguards will be put in place to comply with the HIPAA Security & Privacy Rule in regards to electronic health information, to prevent use or disclosure of client PHI other than provided for use as defined in this document.
3. In addition, Lexington-Fayette Urban County Government's Department of Social Services Substance Abuse and Violence Intervention (SAVI) Program will report any breach (hardcopy or electronic) of which it becomes aware, and shall proceed with breach response steps as required by the Department for Health & Human Services. If at any point LFUCG/SAVI becomes aware that a security incident involves a breach, the entity shall immediately initiate breach response and notify the Lexington-Fayette County Health Department Compliance Officer.
4. LFUCG/SAVI will ensure that any subcontractors that create, receive, maintain, or transmit PHI on behalf of the entity will abide by the same assurances as LFUCG/SAVI.

VII. Duration:


This MOU is at-will and may be modified by mutual consent of authorized officials from the Lexington-Fayette County Urban Government or the Lexington-Fayette County Health Department.


