TEMPORARY CONSTRUCTION EASEMENT

This TEMPORARY CONSTRUCTION EASEMENT is made and entered into this the <u>5</u> day of February, 2020, by and between BURKE FURNITURE, INC., a Kentucky corporation, 2950 Richmond Road, Lexington, Kentucky 40509, which is the in-care of tax mailing address for the current year ("Grantor"), and LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

WITNESSETH:

That for and in consideration of the sum of FOUR THOUSAND ONE HUNDRED DOLLARS AND 00/100 (\$4,100.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantor has BARGAINED and SOLD and does hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Being a portion of the property conveyed to Burke Furniture, Inc., a Kentucky corporation, by deed dated May 1, 1969, of record in Deed Book 961, Page 31 and by deed dated September 21, 1970, of record in Deed Book 998, Page 271 and by deed dated September 10, 1979, of record in Deed Book 1236, Page 72, all referenced in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantor. The temporary construction easement shall take effect upon the

commencement of construction of the project and will expire upon the completion of the

project.

Grantor does hereby release and relinquish unto the Grantee, its successors and

assigns forever, all of its right, title, and interest in and to the property to the extent of

the interest conveyed herein, including all exemptions allowed by law, and does hereby

covenant to and with the Grantee, its successors and assigns forever, that it is lawfully

seized in fee simple of said property and has good right to sell and convey the same as

herein done, and that it will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 605-2015, passed

by the Lexington-Fayette Urban County Council on October 8, 2015. Pursuant to KRS

382.135(2)(c), this temporary construction easement, which pertains to a public right-of-

way, need not contain a statement of consideration.
