

**URBAN COUNTY COUNCIL

Mayor Gray called the meeting to order at 3:00pm. Council Members Kay, Stinnett, Moloney, J. Brown, Smith, Gibbs, Lamb, Farmer, Evans, Worley, F. Brown, Mossotti, Bledsoe and Henson were present. Council Member Plomin was absent.

Motion by Kay to approve the docket for the October 25, 2018 Council meeting. Seconded by Farmer. Motion passed without dissent.

Motion by Worley to place ordinance #7 [an Ordinance changing the zone from a Community Center (B-6P) zone to a Wholesale and Warehouse Business (B-4) zone, for 3.88 net (4.10 gross) acres, for property located at 133 N. Locust Hill Dr.] on the docket without a public hearing. Seconded by Mossotti. Motion passed without dissent.

Motion by Henson to remove ordinance #9 and place it in the Planning & Public Safety Committee for review. Seconded by Lamb. Motion withdrawn.

Motion by Gibbs to place ordinance #6 [an Ordinance changing the zone from a Professional Office (P-1) zone to a Neighborhood Business (B-1) zone, for 0.14 net (0.18 gross) acre, for property located at 521-523 S. Upper St.] on the docket without a public hearing. Seconded by Henson. Motion passed without dissent.

Motion by Smith to place ordinance #8 [an Ordinance changing the zone from a Single Family Residential (R-1D) zone to a Planned Neighborhood Residential (R-3) zone, for 12.58 net (13.83 gross) acres, for property located at 2826 Leestown Rd.] on the docket without a public hearing. Seconded by Henson. Motion passed without dissent.

Council Member Lamb provided a summary of the October 9, 2018 General Government & Social Services Committee meeting.

Motion by J. Brown to allocate funds for training for a parliamentarian in the amount of \$2,500. Seconded by Lamb. Motion passed 9-5. Stinnett, Moloney, J. Brown, Smith, Lamb, Evans, Worley, Mossotti and Bledsoe voted yes. Kay, Gibbs, Farmer, F. Brown and Henson voted no.

Motion by Lamb to approve adding the RFP Language from law as Subsection 3 to Section 1.101 of the Council Rules & Procedures. Seconded by Henson. Motion passed 10-3 as amended. Moloney, J. Brown, Smith, Gibbs, Lamb, Evans, F. Brown, Mossotti, Bledsoe and Henson voted yes. Kay, Farmer and Worley voted no. Stinnett was absent for the vote.

Motion by Bledsoe to amend the language to read “shall be notified of the option to serve on RFP committees”. Seconded by Henson. Motion passed 11-1. Kay, Moloney, J. Brown, Smith, Gibbs, Lamb, Evans, Worley, F. Brown, Mossotti, Bledsoe and Henson voted yes. Farmer voted no. Stinnett was absent for the vote.

Motion by Lamb to approve the amended Council Rules & Procedures resolution and place it on the docket. Seconded by J. Brown. Motion passed without dissent.

Motion by Mossotti to refer the issue of speed limits city wide to the Environmental Quality & Public Works Committee for review. Seconded by J. Brown. Motion passed without dissent.
