## ROZZI INC dba ROZZIS' FAMOUS FIREWORKS DISPLAY CONTRACT

This Agreement entered 7th of April 2025 by and between ROZZI INC dba ROZZIS' FAMOUS FIREWORKS (Rozzi') or ("Seller") of P.O. Box 5, Loveland, Ohio 45140 and Lexington Fayette Urban County Government, Lexington, KY ("Buyer") to be held the 4th day of July 2025 and given by Buyer, and Buyer desires to hire Rozzi's' to furnish and shoot the fireworks display at such event. In consideration of the foregoing and of the covenants, terms, and conditions herein contained, the parties agree as follows:

1. Rozzi's' shall furnish and shoot the fireworks display on July 4th, 2025, at the location of RJ Corman Railyard, 133 Buchanan St, Lexington, KY (Event Site) Rozzi's' agrees to provide experienced operators to set up and fire the fireworks display to comply with regulations outlined in NFPA 1123-2018 edition, ORC §3743.54. OAC 1307;7-7-56 and any local regulations as required by the AHJ.

Please specify a rain out date if applicable: July 5, 2015

- 2. Rozzi's' shall obtain all necessary state and local permits as required by law.
- 3. Rozzi's' shall obtain Public Liability and Property Damage Insurance in an amount of Ten Million Dollars (\$10,000,000.00) and provide Buyer with a Certificate of Insurance showing the amount of insurance in force and naming Rozzi's' as its insured, and Buyer, as an additional insured, and such other parties associated with the event as Buyer may request, and which are approved by Rozzi's' insurance company as the insurer.
- 4. Rozzi's' shall not be responsible for damages to automobiles or other personal property that is parked or located or placed by others within 1000' distance from the mortars to fire the fireworks display. Buyer shall notify spectators who will be viewing the fireworks display of impending fallout from the fireworks display and the potential damage to spectator's automobiles and property by posting warning signs at the Event Site.
- 5. Buyer agrees to pay Rozzi's' the sum of \$23,000.00 for insurance, material, labor, and services rendered in the setup and firing of the fireworks display ("Contract Price"). Payment shall be made as follows: a nonrefundable deposit of \$4600.00 due on the signing of this contract but no later than May 16th, 2025, the balance of \$18,400.00 to be paid within 10 days of completion of the fireworks display but no later than July 14th, 2025.
- 6. In addition, if applicable, Buyer agrees to pay all onsite fire fees charged by the AHJ.
- 7. Buyer and Rozzi's' agree that should the fireworks display be canceled due to rain, high winds, or inclement weather, Buyer shall pay to Rozzi's' in addition to the Contract Price sum in paragraph 6 above the following:
  - (A) 10% of the Contract Price if the display equipment is left in place at the Event Site, and the fireworks display is fired the following night. If the fireworks display is postponed for more than one night, an additional 5% charge would be made for each additional night that the fireworks display is postponed. Should there be a need to require additional security to protect the equipment at the Event Site, all such costs and expenses are to be at the cost and expense of the Buyer and shall be paid to Rozzi's.
  - (B) Should there be a need to dissemble the display equipment and remove it from

the Event Site and reassembled at a subsequent date as agreed upon by the parties, Buyer shall pay Rozzi's' the additional sum of 20% of the Contract Price.

8. Should the event be canceled, and no makeup date set by the parties, the Buyer shall pay Rozzi's' 45% of the Contract Price.

The decision to proceed forward to fire the fireworks display is solely that of Rozzi's,' and it is understood and acknowledged by Buyer that the decision of Rozzi's' not to shoot the fireworks display because of rain, high winds or inclement weather is final and does not constitute a failure of performance by Rozzi's' or a breach of this Agreement.

- 9. Buyer will designate and secure for Rozzi's' adequate space for the fireworks display as required by the Table of Distances outlined in NFPA 1123-2018 edition and provide all such necessary police protection for the Event Site as required by NFPA 1123-2018 edition, ORC §3743.54; OAC 1307;7-7-56 and any local regulations. Rozzi's' will cooperate with reasonable requests made by the AHJ to make compliance with all safety requirements. Should there be a need to meet requirements beyond those required by statute or administrative regulations or the AHJ, the cost incurred to meet those requirements shall be paid by Buyer.
- 10. This Agreement shall not be construed to create a partnership between the parties hereto.
- 11. In the Event of fire, accident, strike, delays, flood, acts of God or other causes beyond the control of the parties, other than those specified in paragraph 7, that would prevent the performance of the fireworks display, the parties hereto release the other from any and all performance obligations herein contained and from any and all damages that result or may result from the inability to perform the fireworks display.

**DISPLAY CONTRACT** 

This Agreement entered this \_\_\_\_\_ day of May 2025 by and between ROZZI, INC. dba ROZZIS' FAMOUS FIREWORKS (Rozzi's') or ("Seller") of P.O. Box 5, Loveland, Ohio 45140 and Lexington Fayette Urban County Government ("Buyer".) WHEREAS Rozzi's' will Display a Drone Display of a typical 12 minutes with a minimum of 200 drones at an event to be held the 20th day of June 2025 and given by Buyer, and Buyer desires to hire Rozzi's' to do the DRONE Display at such event. In consideration of the foregoing and of the covenants, terms, and conditions herein contained, the parties agree as follows:

- 1. Rozzi's' shall furnish and execute the DRONE DISPLAY on June 20th, 2025, at the location of Jacobs Park 4001 Athens Boons Borough Rd- Lexington, KY (Event Site) Rozzi's' agrees to provide experienced Drone Pilots to set up and execute and will comply with regulations outlined in CFR 41-part 107 and any local regulations as required. Rain date to be June 21, 2025.
- 2. Rozzi's' shall obtain all necessary state and local permits as required by law if applicable.
- 3. Rozzi's' shall obtain Public Liability and Property Damage Insurance in an amount of One Million Dollars (\$1,000,000.00) and provide Buyer with a Certificate of Insurance showing the amount of insurance in force and naming Rozzi's' as its insured, and Buyer, as an additional insured, and such other parties associated with the event as Buyer may request, and which are approved by Rozzi's' insurance company as the insurer.
- 4. Buyer agrees to pay Rozzi's' the sum of \$15,000.00 for insurance, material, labor, and services rendered in the setup. ("Contract Price"). Payment shall be made as follows: A nonrefundable deposit of \$3,000.00 is due upon the signing of this contract but no later than June 10th, 2025, the balance of \$12,000.00 to be paid within 10 days of completion of the DRONE DISPLAY but no later than June 30th, 2025.
- 5. Should the event be canceled due to inclement weather conditions that may include rain, high winds and no make-up date set by the parties, the Buyer shall pay Rozzi's' 50% of the Contract Price.
  If the event has to be cancelled and rescheduled the following night due to inclement weather Rozzi's will charge an additional \$1.500.00 plus accommodations for a 4-person crew not to exceed \$500.00.

The decision to proceed forward to fire the DRONE DISPLAY is solely that of Rozzi's,' and it is understood and acknowledged by Buyer that the decision of Rozzi's' not to execute the DRONE DISPLAY because of rain, high winds or inclement weather is final and does not constitute a failure of performance by Rozzi's' or a breach of this Agreement.

- 6. Buyer will designate and secure Rozzi's' adequate space for the display as required and provide all such necessary police protection for the Event Site as required by local regulation. Rozzi's will cooperate with reasonable requests made by the local authority to comply with all safety requirements. Should there be a need to meet requirements beyond those required by statute or administrative, the cost incurred to meet those requirements shall be paid by Buyer.
- 7. This Agreement shall not be construed to create a partnership between the parties hereto.
- 8. In the Event of fire, accident, strike, delays, flood, acts of God or other causes beyond the control of the parties, other than those specified in paragraph 5, that would prevent the performance of the drone display, the parties hereto release the other from any and all performance obligations herein contained and from any and all damages that result or may result from the inability to perform the Drone display.
