The property owner (Richard Conrad) will transfer the proposed ROW portion to C&R Asphalt Land Acquisition Co., LLC., which will accept full responsibility of the maintenance and repair of the right-of-way. The request and pertinent supporting materials were circulated among various divisions and utility representatives to determine impacts to current operations. The comments can be summarized as follows:

LFUCG Divisions:
