

RESOLUTION NO. _____ - 2013

A RESOLUTION CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 1637 COURTNEY AVENUE TO 601 APPLETREE LANE, OF 2280 THUNDERSTICK DRIVE TO 2255 BUENA VISTA ROAD, OF 2051 CAPSTONE DRIVE TO 2031 GEORGETOWN ROAD, OF 333 DESHA ROAD TO 1226 GHENT ROAD, OF 1504 COLESBURY CIRCLE TO 547 WEST NEW CIRCLE ROAD, AND OF 1676 MCGRATHIANA PARKWAY TO 1000 TEMPUR WAY; AND CHANGING THE PROPERTY ADDRESS NUMBER OF 604 EAST HIGH STREET TO 602 EAST HIGH STREET, OF 324-334 SOUTH MARTIN LUTHER KING BOULEVARD TO 326 SOUTH MARTIN LUTHER KING BOULEVARD, OF 346-380 SOUTH MARTIN LUTHER KING BOULEVARD TO 344 SOUTH MARTIN LUTHER KING BOULEVARD, AND OF 1104 STILLWELL AVENUE TO 1100 STILLWELL AVENUE, ALL EFFECTIVE THIRTY DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

(a) Courtney Avenue: That the name of Courtney Avenue located at 1637 Courtney Avenue is changed to Appletree Lane and the following number change is made:

<u>Current</u>	<u>New</u>
1637 Courtney Avenue	601 Appletree Lane

(b) Thunderstick Drive: That the name of Thunderstick Drive located at 2280 Thunderstick Drive is changed to Buena Vista Road and the following number change is made:

<u>Current</u>	<u>New</u>
2280 Thunderstick Drive	2255 Buena Vista Road

(c) Capstone Drive: That the name of Capstone Drive located at 2051 Capstone Drive is changed to Georgetown Road and the following number change is made:

<u>Current</u>	<u>New</u>
2051 Capstone Drive	2031 Georgetown Road

(d) Desha Road: That the name of Desha Road located at 333 Desha Road is changed to Ghent Road and the following number change is made:

<u>Current</u>	<u>New</u>
333 Desha Road	1226 Ghent Road

(e) Colesbury Circle: That the name of Colesbury Circle located at 1504 Colesbury Circle is changed to West New Circle Road and the following number change is made:

<u>Current</u>	<u>New</u>
1504 Colesbury Circle	547 West New Circle Road

(f) McGrathiana Parkway: That the name of McGrathiana Parkway located at 1676 McGrathiana Parkway is changed to Tempur Way and the following number change is made:

<u>Current</u>	<u>New</u>
1676 McGrathiana Parkway	1000 Tempur Way

Section 2 – That the street numbers of the following properties be and hereby are changed as follows:

(a) East High Street:

604 East High Street	602 East High Street

(b) South Martin Luther King Boulevard:

324-334 S. Martin Luther King Boulevard	326 S. Martin Luther King Boulevard

(c) Stillwell Avenue:
