

COMMUNITY PROJECT AGREEMENT

THIS COMMUNITY PROJECT AGREEMENT (“Agreement”), is made and entered into on the 4th day of November 2022, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the COMMONWEALTH OF KENTUCKY created pursuant to KRS Chapter 67A (“LFUCG”), 200 East Main Street, Lexington, Kentucky 40507, and **CENTRAL CHRISTIAN CHURCH (DISCIPLES OF CHRIST), INC.**, Kentucky nonprofit corporation, (“Organization”) with offices located at 219 East Short Street, Lexington, Kentucky 40507.

WITNESSETH

WHEREAS, the Organization is a 501(c)(3) nonprofit organization, as defined by the Internal Revenue Code, that owns the property located at 219 East Short Street, Lexington, Kentucky 40507, also known as “The Watkins Building” (“Property” or “Properties);

WHEREAS, the Organization provides aide to residents of Fayette County who are low-income, underserved, and/or marginalized;

WHEREAS, LFUCG issued Request for Proposal (RFP) No. 24-2022 for its “Nonprofit Capital Grants Program,” which offers grant awards to Fayette County 501(c)(3) nonprofit organizations in recognition of the negative economic impacts of COVID-19 upon the local network of community agency partners;

WHEREAS, the Organization submitted a response to RFP No. 24-2022 seeking funding from LFUCG for operational investment projects and/or capital improvement projects so that it can budget appropriate funds to continue providing needed services to Fayette County residents;

WHEREAS, LFUCG intends to fund projects, to hopefully lessen the economic impact of the COVID-19 pandemic on those Fayette County residents served by the Organization using revenue replacement funding derived from the American Rescue Plan Act of 2021 (ARPA);

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the receipt and sufficiency of which are acknowledged, the parties hereby agree as follows:

1. **EFFECTIVE DATE; TERM.** This Agreement shall commence on October 15, 2022 and shall last until December 31, 2026, unless terminated by LFUCG at an earlier time.

2. **RELATED DOCUMENTS.** This Agreement shall consist of the terms herein as well as the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:

- A. Exhibit “A” – Request for Proposal, Risk Management Provisions, and Scope of Project
- B. Exhibit “B” – Response to Request for Proposal

To the extent that there is any conflict between or among any of these documents, the terms and provisions of this Agreement shall prevail, followed by terms and provisions of Exhibit "A", then Exhibit "B", in that order.

3. **SCOPE OF WORK.** Organization shall complete the Scope of Project outlined in the attached Exhibit "A" (the "Project(s)"), which are further specified in Numbered Paragraph 4 of this Agreement. The Organization shall complete these Projects in a timely, workmanlike and professional manner, as specified herein.

4. **PAYMENT.** LFUCG shall pay Organization a total amount not to exceed **TWO HUNDRED FORTY-EIGHT THOUSAND TWO HUNDRED FIFTY-FOUR DOLLARS (\$248,254)** ("**Funds**") for the completion of the following Project(s):

The uses of the Funds are limited to the Projects described in this numbered Paragraph and shall be consistent with the Scope of Project outlined in attached Exhibit A. The Funds may not be spent by the Organization for any other purpose without the prior written consent of LFUCG. Absent any additional written agreement stating otherwise, any travel or other expenses are excluded from the above payment schedule.

a. LFUCG shall make payment under this Agreement upon timely submission of an invoice(s) from Organization specifying that nature of work performed, accompanied by data satisfactory to LFUCG to document entitlement to payment for work completed to date. LFUCG shall have thirty (30) days from the date of receipt of the invoice to pay the invoice amount. LFUCG reserves the right to refuse payment if it is determined by LFUCG that any of the work performed on the Projects is inadequate or defective.

b. LFUCG also reserves the right to reject any invoice submitted for services more than sixty (60) days after the services were rendered.

5. **FEDERAL LAW.** The Organization understands that the Funds paid by LFUCG were awarded under the American Rescue Plan Act of 2021 ("ARPA"). Organization agrees to comply with any requests from LFUCG related to LFUCG's ongoing monitoring and reporting obligations set by federal law. Organization understands that the failure to comply may result in termination of this Agreement. Organization further agrees and by entering this Agreement, it hereby certifies

to its ability to comply with all terms included within Exhibits A and B and also to the following terms, to the extent these terms are applicable to the subject matter of this Agreement as defined by applicable federal law:

a. The Organization acknowledges and certifies that it has not been debarred or suspended and further acknowledges and agrees that it must comply with regulations regarding debarred or suspended entities in accordance with 24 CFR § 570.489(l). Funds may not be provided to excluded or disqualified persons.

b. The Organization agrees and certifies that to the greatest extent practicable, it will prefer the purchase, acquisition, and use of goods, products or materials produced in the United States, in conformity with 2 C.F.R. § 200.322.

c. The Organization agrees and certifies that all activities performed pursuant to any agreement entered as a result of a contractor's bid, and all goods and services procured under that agreement, shall comply with 2 C.F.R. § 200.216 (Prohibition on certain telecommunications and video surveillance services and equipment) and 2 C.F.R. 200 § 200.323 (Procurement of recovered materials), to the extent either section is applicable.

6. **TERMINATION.** LFUCG, through the Mayor or the Mayor's designee, may terminate this Agreement for any reason whatsoever by providing Organization with at least thirty (30) days advance written notice. Organization shall be entitled for payment of all work performed up to that period of time, calculated on a reasonable basis.

a. In the event of a termination based upon a material condition of non-performance or default by Organization, LFUCG shall provide Organization with advance written notice and a reasonable period of time to cure the breach.

b. Organization may only terminate this Agreement based upon LFUCG's failure to timely pay for properly invoiced and accepted work. Organization shall provide LFUCG with at least thirty (30) days' advance written notice and an opportunity to cure prior to termination.

c. Organization acknowledges that LFUCG is a governmental entity, and that the validity of this Agreement is based upon the availability of appropriated funding. In the event that such funding is not appropriated in a future fiscal year, LFUCG's obligations under this Agreement shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Organization. LFUCG shall exercise any application of this provision in good faith.

7. **REPORTING.** Organization shall provide LFUCG with timely quarterly reports and updates related to the completion of the Projects in the form and manner reasonably specified by LFUCG.

8. **REGISTRATION; COMPLIANCE; AUTHORITY TO SIGN.** Organization shall be lawfully registered or authorized to do business in the Commonwealth of Kentucky and Lexington-Fayette County and shall at all times comply with any and all applicable federal, state, and local laws, ordinances, and regulations. LFUCG may request proof that Organization has timely filed

federal, state, or local tax forms which shall be provided by Organization on a timely basis. The person signing this Agreement on behalf of Organization is fully authorized to do so.

9. **INSURANCE; INDEMNITY.** The Risk Management Provisions in Exhibit "A" are incorporated herein as if fully stated.

10. **RECORDS.** Organization shall keep and make available to LFUCG any records related to this Agreement as are necessary to support its performance of the services for a period of at least five (5) years following the expiration or termination of this Agreement, or as otherwise required depending upon the source of funds. Books of accounts shall be kept by Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of Organization related to this Agreement and shall be made available to LFUCG upon request.

a. LFUCG shall be the owner of all final documents, data, studies, plans, reports, and information prepared by Organization under this Agreement.

b. Organization understands and agrees that this Agreement and any related documents may be subject to disclosure under the Kentucky Open Records Act and will comply with any reasonable request by LFUCG to provide assistance with such a request.

11. **ACCESS.** Organization shall allow LFUCG any necessary reasonable access to monitor its performance under this Agreement.

12. **CONTRACTUAL RELATIONSHIP ONLY.** In no event shall the parties be construed, held or become in any way for any purpose the employee of the other party, or partners, associates or joint ventures in the conduct of their respective endeavors or otherwise.

13. **EQUAL OPPORTUNITY; FAIRNESS ORDINANCE.** Organization shall provide equal opportunity in employment for all qualified persons, and shall (a) prohibit discrimination in employment because of race, color, creed, national origin, sex, age, sexual orientation, gender identity, or handicap, (b) promote equal employment through a positive, continuing program of equal employment, and (c) cause any subcontractor or agency receiving funds provided pursuant to this Agreement to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices. Organization agrees to comply with LFUCG's Fairness Ordinance (Ordinance No. 201-99) and all sources of applicable law, including those specified in any Exhibit attached to this Agreement and incorporated herein by reference.

14. **SEXUAL HARASSMENT.** Organization must adopt or have adopted a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be made available to LFUCG upon request.

15. **DISPOSITION OF PROPERTY.** Organization agrees that it shall not sell or otherwise dispose of any goods, property, or equipment acquired and/or improved with any portion of the

Funds without first obtaining the consent of LFUCG. Organization agrees that this provision shall survive termination of the Agreement, if this Agreement terminates prior to December 31, 2026. If Organization breaches this provision, Organization may be liable to LFUCG for that breach in an amount that shall not exceed the fair market value of the goods, property and/or equipment that it sold or otherwise transferred. LFUCG further reserves the right to enforce this provision through any remedy available at law, equity, or in bankruptcy.

16. **INVESTMENT**. Any investment of the Funds received pursuant to this Agreement must fully comply with any restrictions imposed by law.

17. **NO ASSIGNMENT**. Organization may not assign any of its rights and duties under this Agreement without the prior written consent of LFUCG.

18. **NO THIRD PARTY RIGHTS**. This Agreement does not create a contractual relationship with or right of action in favor of a third party against either Organization or LFUCG.

19. **KENTUCKY LAW AND VENUE**. This Agreement shall be governed in all respects by the laws of the Commonwealth of Kentucky and venue for all actions shall lie in the Circuit Court of Fayette County, Kentucky.

20. **AMENDMENTS**. By mutual agreement, the parties to this Agreement may, from time to time, make written changes to any provision hereof. Organization acknowledges that LFUCG may make such changes only upon approval of its legislative authority, the Lexington-Fayette Urban County Council, and the signature of its Mayor.

21. **NOTICE**. Any written notice required by the Agreement shall be delivered by certified mail, return receipt requested, to the following:

22. **WAIVER**. The waiver by either party of any breach of any provision of this Agreement

shall not constitute a continuing waiver or waiver of any subsequent breach by either party of either the same or another provision.

23. **ENTIRE AGREEMENT.** This Agreement shall constitute the entire agreement between the parties and no representations, inducements, promises or agreements, oral or otherwise, which are not embodied herein shall be effective for any purpose. This Agreement shall replace any previous agreement between the parties on the same subject matter.

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #24-2022 Nonprofit Capital Grants Program** to be provided in accordance with terms, conditions and specifications established herein.

Online proposals will be received at <https://lexingtonky.ionwave.net/> until **2:00 PM**, prevailing local time, on **June 21, 2022**

Proposals received after the date and time set for opening proposals will not be considered for award of a contract and will be returned unopened to the Proposer. It is the sole responsibility of the Proposer to assure that his/her proposal is received (uploaded to <https://lexingtonky.ionwave.net/>) by the Division of Central Purchasing before the date and time set for opening proposals.

Additional copies of this Request For Proposals are available from the Division of Central Purchasing, Room 338 Government Center, 200 East Main Street, Lexington, KY 40507, (859)-258-3320, at no charge.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Proposer must upload one (1) electronic version in PDF format to <https://lexingtonky.ionwave.net/>.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Signature of this proposal by the Proposer constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

The Lexington-Fayette Urban County Government encourages the participation of minority- and women-owned businesses in Lexington-Fayette Urban County Government contracts. This proposal is subject to Affirmative Action requirements attached hereto.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, ordinances and resolutions (including but not limited to Section 2-33 (Discrimination due to sexual orientation or gender identity) and Chapter 13 (Licenses and Regulations) of the Lexington-Fayette Urban County Government Code of Ordinances, and Resolution No. 484-17 (Minority, Women, and Veteran-Owned Businesses)) and the regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, religion, sex (including pregnancy, sexual orientation or gender identity), national origin, disability, age, genetic information, political affiliation, or veteran status, and to promote equal employment through a positive, continuing program from itself and each of its sub-contracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;
- (3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and
- (4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available workforce in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

Contention Process

Vendors who respond to this invitation have the right to file a notice of contention associated with the RFP process or to file a notice of appeal of the recommendation made by the Director of Central Purchasing resulting from this invitation.

Notice of contention with the RFP process must be filed within 3 business days of the bid/proposal opening by (1) sending a written notice, including sufficient documentation to support contention, to the Director of the Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his/her contention with the RFP process. After consulting with the Commissioner of Finance the Chief Administrative Officer and reviewing the documentation and/or hearing the vendor, the Director of Central Purchasing shall promptly respond in writing findings as to the compliance with RFP processes. If, based on this review, a RFP process irregularity is deemed to have occurred the Director of Central Purchasing will consult with the Commissioner of Finance, the Chief Administrative Officer and the Department of Law as to the appropriate remedy.

Notice of appeal of a RFP recommendation must be filed within 3 business days of the RFP recommendation by (1) sending a written notice, including sufficient documentation to support appeal, to the Director, Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his appeal. After reviewing the documentation and/or hearing the vendor and consulting with the Commissioner of Finance and the Chief Administrative Officer, the Director of Central Purchasing shall in writing, affirm or withdraw the recommendation.

SELECTION CRITERIA:

See Scope of Work for scoring criteria.

Proposals shall contain the appropriate information necessary to evaluate based on these criteria. A committee composed of government employees as well as representatives of relevant user groups will evaluate the proposals.

AFFIDAVIT

Comes the Affiant, Mollie P. Sawyer, and after being first duly sworn, states under penalty of perjury as follows:

1. His/her name is Mollie P. Sawyer and he/she is the individual submitting the proposal or is the authorized representative of Central Christian Church (DOC) INC., the entity submitting the proposal (hereinafter referred to as "Proposer").

2. Proposer will pay all taxes and fees, which are owed to the Lexington-Fayette Urban County Government at the time the proposal is submitted, prior to award of the contract and will maintain a "current" status in regard to those taxes and fees during the life of the contract.

3. Proposer will obtain a Lexington-Fayette Urban County Government business license, if applicable, prior to award of the contract.

4. Proposer has authorized the Division of Central Purchasing to verify the above-mentioned information with the Division of Revenue and to disclose to the Urban County Council that taxes and/or fees are delinquent or that a business license has not been obtained.

5. Proposer has not knowingly violated any provision of the campaign finance laws of the Commonwealth of Kentucky within the past five (5) years and the award of a contract to the Proposer will not violate any provision of the campaign finance laws of the Commonwealth.

6. Proposer has not knowingly violated any provision of Chapter 25 of the Lexington-Fayette Urban County Government Code of Ordinances, known as "Ethics Act."

7. Proposer acknowledges that "knowingly" for purposes of this Affidavit means, with respect to conduct or to circumstances described by a statute or ordinance defining an offense, that a person is aware or should have been aware that his conduct is of that nature or that the circumstance exists.

EQUAL OPPORTUNITY AGREEMENT

The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, 29 U.S.C. 650 *et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.

6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted

to bribe an officer or employee of the LFUCG.

9. **Additional Information:** While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
10. **Ambiguity, Conflict or other Errors in RFP:** If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. **Agreement to Bid Terms:** In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
12. **Cancellation:** If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.

- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
- (a) Failure to perform the contract according to its terms, conditions and specifications;
 - (b) Failure to make delivery within the time specified or according to a delivery schedule fixed by the contract;
 - (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
 - (d) Failure to diligently advance the work under a contract for construction services;

 - (f) Actions that endanger the health, safety or welfare of the LFUCG or its citizens.

B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.
14. **No Waiver:** No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and

authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must be signed by a duly authorized officer, agent or employee of the Respondent.

16. **Governing Law:** This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
17. **Ability to Meet Obligations:** Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. Contractor [or Vendor or Vendor's Employees] will not appropriate or make use of the Lexington-Fayette Urban County Government (LFUCG) name or any of its trade or service marks or property (including but not limited to any logo or seal), in any promotion, endorsement, advertisement, testimonial or similar use without the prior written consent of the government. If such consent is granted LFUCG reserves the unilateral right, in its sole discretion, to immediately terminate and revoke such use for any reason whatsoever. Contractor agrees that it shall cease and desist from any unauthorized use immediately upon being notified by LFUCG.

20. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

**AMENDMENT 1 —
CERTIFICATION OF COMPLIANCE FOR AMERICAN RESCUE PLAN ACT

Therefore, by the signature below of an authorized company representative, you certify that the information below is understood, agreed, and correct. Any misrepresentations may result in the termination of the contract and/or prosecution under applicable Federal and State laws concerning false statements and false claims.

The bidder agrees and understands that in addition to all conditions stated within the attached bid documents, the following conditions will also apply to any Agreement entered between bidder and LFUCG, if LFUCG classifies the subject matter of this bid as an expenditure under the American Rescue Plan Act. The bidder further certifies that it can and will comply with these conditions, if this bid is accepted and an Agreement is executed:

1. Any Agreement executed as a result of acceptance of this bid may be governed in accordance with 2 CFR Part 200 and all other applicable Federal law and regulations and guidance issued by the U.S. Department of the Treasury.

2. Pursuant to 24 CFR 85.43, any Agreement executed as a result of acceptance of this bid can be terminated if the contractor fails to comply with any term of the award. This Agreement may be terminated for convenience in accordance with 24 CFR 85.44 upon written notice by LFUCG. Either party may terminate this Agreement with thirty (30) days written notice to the other party, in which case the Agreement shall terminate on the thirtieth day. In the event of termination, the contractor shall be entitled to that portion of total compensation due under this Agreement as the services rendered bears to the services required. Either party may terminate this Agreement for good cause shown with forty-five (45) days written notice, which shall explain the party’s cause for the termination. If the parties do not reach a settlement before the end of the 45 days, then the Agreement shall terminate on the forty-fifth day.

3. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The contractor will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:

- (1) Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

- (2) The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin.
- (3) The contractor will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or another employee or applicant. This provision shall not apply to instances in which an employee who has access to the compensation information of other employees or applicants as a part of such employee's essential job functions discloses the compensation of such other employees or applicants to individuals who do not otherwise have access to such information, unless such disclosure is in response to a formal complaint or charge, in furtherance of an investigation, proceeding, hearing, or action, including an investigation conducted by the employer, or is consistent with the contractor's legal duty to furnish information.
- (4) The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- (5) The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- (6) The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (7) In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part, and the contractor may be declared ineligible for further government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- (8) The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance.

Provided, however, that in the event a contractor becomes involved in or is threatened with litigation with a subcontractor or vendor as a result of such direction by the administering

agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

4. If fulfillment of the contract requires the contractor to employ mechanic's or laborers, the contractor further agrees that it can and will comply with the following:

LFUCG shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) of this section.
- (4) Subcontracts. The contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraph (1) through (4) of this section and also a clause requiring the subcontractors to include these clauses in any lower-tier subcontracts. The prime contractor shall be responsible for compliance by any subcontractor or lower-tier subcontractor with the clauses set forth in paragraphs (1) through (4) of this section.

5. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Clean Air Act, as amended, 42 U.S.C. § 7401 et seq.

6. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency Regional Office.

7. The contractor shall include these requirements in numerical paragraphs 5 and 6 in each subcontract exceeding \$100,000 financed in whole or in part with American Rescue Plan Act funding.

8. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 et seq.

9. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency Regional Office.

10. The contractor shall include these requirements in numerical paragraphs 8 and 9 in each subcontract exceeding \$100,000 financed in whole or in part with American Rescue Plan Act funds.

11. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 et seq.

12. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency regional office.

13. The contractor shall include these requirements in numerical paragraphs 11 and 12 in each subcontract exceeding \$100,000 financed in whole or in part with American Rescue Plan Act funds.

14. **RISK MANAGEMENT PROVISIONS
INSURANCE AND INDEMNIFICATION**

INDEMNIFICATION AND HOLD HARMLESS PROVISION

- (1) It is understood and agreed by the parties that Consultant hereby assumes the entire responsibility and liability for any and all damages to persons or property caused by or resulting from or arising out of any act or omission on the part of Consultant or its employees, agents, servants, owners, principals, licensees, assigns or subcontractors of any tier (hereinafter "Consultant") under or in connection with this agreement and/or the provision of goods or services and the performance or failure to perform any work required thereby.
- (2) Consultant shall indemnify, save, hold harmless and defend the Lexington-Fayette Urban County Government and its elected and appointed officials, employees, agents, volunteers, and successors in interest (hereinafter "LFUCG") from and against all liability, damages, and losses, including but not limited to, demands, claims, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Consultant's performance or breach of the agreement and/or the provision of goods or services provided that: (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Consultant; and (b) not caused solely by the active negligence or willful misconduct of LFUCG.
- (3) Notwithstanding, the foregoing, with respect to any professional services performed by Consultant hereunder (and to the fullest extent permitted by law), Consultant shall indemnify, save, hold harmless and defend LFUCG from and against any and all liability, damages and losses, including but not limited to, demands, claims, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees, for any damage due to death or injury to any person or injury to any property (including the loss of use resulting therefrom) to the extent arising out of, pertaining to or relating to the negligence, recklessness or willful misconduct of Consultant in the performance of this agreement.
- (4) In the event LFUCG is alleged to be liable based upon the above, Consultant shall defend such allegations and shall bear all costs, fees and expenses of such defense, including but not limited to, all reasonable attorneys' fees and expenses, court costs, and expert witness fees and expenses, using attorneys approved in writing by LFUCG, which approval shall not be unreasonably withheld.

- (5) These provisions shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this agreement.

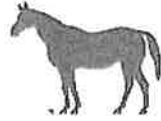

SECTION 1

About

Central Christian Church, a 501(c) (3) nonprofit organization, is located at 205 East Short Street in downtown Lexington, Kentucky, has a rich and long history of serving families and children from varied and diverse backgrounds. Central Christian Church is affiliated with the Christian Church (Disciples of Christ) and was founded in 1816. Our campus is spread across four acres (1.62 hectares) it features the sanctuary building, a prayer garden, and our Outreach building serving various social outreach programs and other non for profits.

Central Christian Church, a Founding Disciples of Christ congregation serving in the heart of Lexington, is committed to extending compassion, mercy, and justice to our neighbors through our Outreach Ministries. These outreach initiatives seek to meet the needs of individuals, families, and our community through volunteerism, financial support, partnerships, relationships, and activism.

Central Christian Church is in good standing with the Kentucky Secretary of State and has been awarded the Gold Seal of Transparency with GuideStar. We do not proselytize or promote any religious philosophies with those we serve in our long-standing social outreach programming. As well, we agree to comply with all applicable local, state, and federal laws.

The Watkins Building

The staff and leadership are seeking funds for capital and operational improvements for our facility that serves and supports the many outreach and social programs we

facilitate. The building the church calls, "The Watkins Building", located at 219 E. Short St., was originally build in 1948 as the southeastern headquarters and bus station for Greyhound. The Watkins Building has always been an instrument of vital service in downtown Lexington. Since the church took over ownership of the building in 1973 we have reconfigured the space many times for our use to support various outreach and educational programs; a Clothing Shop, Sunday School classes, Youth Center, Book Shop, Café, Child Development Center, an Adult Day Center and to accommodate our administrative offices. We now house our Thrift Store, a God's Pantry client pick up spot, a homeless outreach program called Helping Hands and have a dedicated space for supporting a local school, William Wells Brown Elementary. Along with our staff offices on the second floor, several other offices are rented to local justice non for profits and to Micah Legal which provides legal services on an income-based fee schedule. And lastly a local AA group meets once a week in one of our rooms and has been doing so since the early 1980's. Currently we are working on a partnership with St. James Place to provide a space for hiring a Social Worker to be on-site five days a week to provide help to all the clients using our outreach programs. This summer we are starting a partnership with Christ Church Cathedral in downtown Lexington to begin our free clothing program called Community Closet. It might be a surprise to hear but the Watkins Building is the most used space on our campus. The number of people who are served, on a monthly basis, is 2,000+, through all the programs and non for profits that share space. Such an important space needs a lot of care. The more a space is used the more maintenance it needs.

The Central Outreach Programs housed in the Watkins Building are listed below:

Helping Hands

Helping Hands is a program that shows respect and love for homeless and others in need every month by distributing donated and purchased personal items (e.g. hotel size toiletries, socks, ChapStick, dental items, deodorant, bus tickets and much more).

These items are donated by members of our church and/or purchased by donations and funding from the church. The numbers of those we serve grow monthly but currently range from 120 to 140 per month. Items are distributed from 10 am to 12 pm on Monday and Wednesday of the first and third full week of every month in the McCullough Room of the Watkins Building. The program was started in the mid 2000's.

The Thrift Shop

The Thrift Shop has been open for more than 30 years. The shop offers inexpensive and high-quality second-hand clothing. The prices are low so that the Lexington community can find good quality clothing for less than \$5.00. All the funds raised through items purchased go back into the outreach programs Central Christian Church supports. The Thrift Shop is open 5 days a week, noon to 3 pm, on the first floor of the Watkins Building.

God's Pantry

In 2004 we partnered with God's Pantry to be the downtown location for food distribution to those in need, Monday-Friday. Since our partnership, we have continued to serve, even through these last two years of the pandemic, an average of 60 to 70 families per day. Central is undoubtedly committed to partnering with God's Pantry for the foreseeable future.

William Wells Brown Elementary School Relationship

In 2017 the church set out to help a school in our neighborhood. A need was determined for us to support WWB school by the superintendent 's office because 90% of the children are on a free lunch and breakfast program. The church has been in partnership with the school through many programs.

We have a room in our Watkins building that provides the space for this program where we sort, pack, and process all the donations and services we provide to WWB. Through Feeding America, we pack 120 weekend snack bags every week with 9 items in each bag. Also, during the summer, we provide food for a four-week food program which is 60 bags per week. This past year the church raised \$12,000 to support both food programs. Every winter the church donates pajamas and socks for every child in the school, serving 320 children each year, on average.

Every Fall we partner with the school to help the teachers with school supplies. Each year Central Christian Church provides approximately \$7,000 worth of supplies. At the same time, we sponsor the fall orientation food for the children and parents. A new program we have been able to provide in the last year has been hygiene kits for the older students at a cost for supplies at \$700. Lastly, we have partnered with WWB through the 21st Century Federal Afterschool Program to help create a garden project on the property. In 2018 Central was awarded the Golden Apple awarded from the school system to celebrate all our support of the children and parents of William Wells Brown. These are OUR kids!!

Community Closet

Central and Christ Church Cathedral are starting a partnership in July 2022 to provide free clothing to the community. It will be a program that is open every Saturday from 10am to 12pm, fully staffed by volunteers. Central will be the host for the program providing the space needed to let clients select the items they need. The goal is to serve 30 to 50 families per week. This is yet another new program that will be housed in The Watkins Building, so new updates and repairs to this space are well needed and will add value for decades to come.

Organization Partners We Support with the Watkins Building:

Micah Legal is a nonprofit, sliding-scale law office, providing high quality civil legal services to Lexingtonians who cannot afford to hire a market rate attorney. Located inside the Watkins Building since it was founded, Micah Legal serves individuals and families with incomes up to 400% of the Federal Poverty Guidelines. Half of the clientele of Micah Legal are living with incomes at or below the poverty line and have been turned away from Legal Aid.

The mission of Micah Legal is to increase access to justice for low-income Lexingtonians, and they have been doing so for over five years. Micah Legal has three full-time attorneys and one part-time attorney who provide affordable services in the areas of family law (70%), estate planning (20%), and expungements (10%). Among the family law clients of Micah Legal, a third or more are survivors of domestic violence who have been referred through their partnerships with The Nest and GreenHouse17. Micah Legal works in close partnership with other local nonprofits to meet the legal needs of their shared clients, as well; organizations including: Bluegrass

Care Navigators, St. James Place, The Fatherhood Initiative, and more. In an average month, Micah Legal serves 200 or more clients out of the Watkins Building.

Korean Methodist Christian Church

The Korean Methodist Christian Church rents our small chapel for their worship service and bible study. On Sunday's we provide a room in the Watkins Building so they can share a meal together. We have partnered with them since 2010.

SECTION 2

Demonstrated Need

The poverty rate in Lexington-Fayette is 15.8%, as stated on www.worldpopulationsreview.com. In the last year, 56,039 of 301,778 Lexington-Fayette residents reported income levels below the poverty line. Downtown Lexington where Central Christian Church is located, has one of the highest poverty rates of the city. The zip code of 40507, where Central Christian Church is located, has the second highest rates in Lexington with a 19.10%. The Lexington zip code of 40508 has the highest poverty rate of all zip codes in Lexington at 31.21%. The lowest poverty rate is found in zip code 40514 at 1.36%. A Lexington social worker and Executive Director for the East End Development Corporation, Billie Mallory, asked the Urban County Council to do something about what she says is an increasing homeless population in the East end. "I'm not against the homeless, I'm a social worker, and I've worked with the homeless about 15 years. But this is different, this is a different kind of homeless" said Mallory. Billie Mallory says her concerns are with people at Third Street and Martin Luther King corner and Third Street

and Elm Tree corner. Source: Lexington Herald Leader, June 16, 2021. Central Christian Church is the anchor in this neighborhood. We see and know that our vulnerable neighbors need care and support. We are absolutely committed to helping our city address the lives impacted by homelessness.

As presented in the history and vitality of the Watkins Building, one can identify how important the facility has been historically, as well as currently, in providing services to low-income, and at times, highly fragile individuals and families. Families we serve are vulnerable and suffer as a result. To better serve them, we must have a safe, solid building structure for many decades to come. Our building is in dire need for repairs, restoration, and renovation. We know that once this building is made safer with improved accessibility, working HVAC, new elevator, new windows, a better security system, among many other capital improvements, we will be better able to serve even more individuals in need of our services. SECTION 3

Applicant Capacity for Project and Meeting ARPA Requirements

The Watkins Building is in dire need of capital improvements so that we can continue this vital work on behalf of vulnerable individuals, families, and children. We are wholeheartedly committed to improving outcomes for those we serve. A refreshed, repaired, and renovated Watkins Building will ensure that our commitment will be manifested. At Central Christian Church we fully understand the expectations, rules, and policies of the

American Rescue Plan Act. We have the internal capacity to seek proper bids, choose the best one, prioritize projects, and provide proper oversight in the whole process as evidenced by our long and successful history of facility project management.

Central Christian Church has a long history of managing a large campus of buildings, their upkeep, a very large parking lot, and the programming that inhabits this extensive campus. Lexington with the amazing help from the ARPA funds. Through our Board of Directors and SR Staff all projects will be managed and have detailed oversight, as with all current daily manage of our campus already has. We believe we have the tenacity, the skill sets, the expertise, and the love to make sure our projects are well managed to bring hope to those in downtown Lexington.

We have secured the bids for a majority (approximately 80%) of our proposed capital and operational needs for The Watkins Building stated in this document. Once we are notified of our success in achieving the contract with LFUCG, we are ready to set forth in getting our vendors ready to begin within thirty days! This is a distinct and real advantage in our proposal. These bid documents are available upon request.

We are committed to following all local, state, and federal rules and guidelines and are fully aware of the expectations of the ARPA federal grant funds. We are open to all support and technical assistance from LFUCG, the federal government, and will provide all reports and documents needed. Our financials are audited yearly by a local CPA firm and organized in a way that will allow us to keep all ARPA projects separated. We are committed to a diverse work force, hoping to provide contracts for work done to minority-owned businesses. Social justice is one of the most important tenants of Central Christian Church. It is one we take seriously as witnessed in our social

programming. We do not proselytize, nor do we promote any religious philosophies to the individuals we serve. We only wish to provide quality and meaningful services to our community of downtown Lexington as part of our mission.

Gary joined the church staff team in December of 2020. Gary's experience in construction, project management and safety and security knowledge are invaluable to the Church and our staff. He has five years' experience as a project manager in construction and renovation, thirty-five plus years in residential construction with various commercial experience, twenty-one years as owner/operator of his own renovation/construction company, twenty years in training/teaching while in the Fire Service, and twenty plus years' experience in providing building inspections for FHA/HUD/State.

All of the Outreach Programs of Central Christian Church also have a volunteer manager, who is a member of our church. Each manager reports to the staff on a weekly basis through our staff meetings. Many members of our church are committed to the outreach programming of Central through their volunteer work. As well, many of our most committed volunteers are members of our community, but do not belong to our congregation. Having a variety and diversity of volunteers makes for a rich partnership in serving our community. All volunteers are carefully vetted, trained in child protection, family safety, cultural competence, diversity, and inclusion. Our volunteers are vital to the success of our programming.

SECTION 4

Operational Feasibility

With the number and variety of capital and operational needs projected in this proposal

for the Watkins Building, determining a timeline has a few challenges. There must be an order that is organic and makes sense. Once the grant has been awarded, we will first address the most imminent needs to be completed while other projects can be completed concurrently such as a new fire alarm system, new elevator, windows, HVAC system, porch roof, the construction of the new offices in the interior, and lastly the technology system work. We will work with the contractors in establishing realistic timelines with our prioritized list of projects. We understand timelines and deadlines as we have a proven track record of accountability in completing all of our previous capital projects, including our 2010 church building renovation. Central Christian Church does have an experienced, strong Leadership in our Property Committee that works closely with our staff and contracted vendors. One big advantage is that we have already attained approximately 80% of our project bids. Having those in place ensures that we can begin within thirty days of receiving the award!

In the unlikely chance that funding runs short for any of the proposed capital projects, Central Christian Church will jump in and ask our congregants to step up with some special giving for The Watkins Building. We are also prepared to research other grant opportunities for The Watkins Building. The Watkins Building has all the hope and promise to bring our mission of service to fruition for decades to come. We must be good stewards of the building that has been so supported by the United States' taxpayers if we are to be awarded this grant. We take this opportunity seriously and mindfully as we go forward.

We do have a good number of qualified staff to carry out the goals and timelines of the project (please see the brief bios in Section 3). We strongly feel our church has the

expertise and proven track record of managing large and complex capital improvement projects. We feel quite comfortable in managing it in its totality with completion in April of 2024.

SECTION 5

Watkins Building Capital Projects

As presented in the history and vitality of the Watkins Building, one can identify how important the facility has been historically as well as currently in providing services to low-income, at times, fragile individuals, and families. Families we serve are vulnerable and suffer as a result. To better serve them, we must have a safe, solid building structure for many decades to come. This building is in dire need for repairs, restoration, and renovations. We know that once this building is made safer with improved accessibility, working HVAC, new elevator, new windows, a better security system, among many other operational and facility improvements, we will be better able to serve even more individuals in need of our services. Central Christian Church is the cornerstone for downtown Lexington, offering vital outreach programs that create a safe place for our community of neighbors. With better facilities, we will be in the position to grow partnerships, relationships, and friendships that will ultimately impact better outcomes for individuals, families and children.

Operational Investments (1 project)

Elevator Replacement-Our current elevator is no longer repairable due to age and vendor unable to find parts, it dates from 2008. Currently the elevator is out of service and all client's/church members/guests must call the office or non for profit to set up

meetings on the first floor. The cost is very expensive for the church, but the need is great for people to access our second floor. **DC Elevator \$55,200**

Fire Alarm System Replacement-Current system is more than 30 years old. All parts of the system can no longer be upgraded. The Church will have to make the choice to replace the whole system at some point. It would be a very big expense for the us, but not one we can forgo any longer. **New Tech and Elliott Electrical \$147,000**

Computer System Upgrades: To create an optimal working space for our volunteers, staff and clients, a new **WiFi segregated system** must be available for first floor. **Other system upgrades** include replacing our server, which is 10 years old, with a new system and other access upgrades.

Safety for our clients and our staff is of high priority for the Watkins Building. We need to upgrade our security system with an **increased number of cameras. An Additional Keypad System** installed will add to the security of the Watkins Building. **All computer upgrades and safety projects total \$46,054.**

Facility Improvements (4 projects)

1. Exterior of Watkins Building

Porch Roof replacement \$36,000. We have much to do on repairing our porch, which has seen the deterioration of our columns over the last month. The only bid we have thus far is the roof replacement. We currently do not know the other costs associated with repairing our porch, nor do we know to the full extent what the insurance company will be covering on this project.

Window replacement is vitally necessary. Windows date from the 1980's, some are original to 1948, most cannot open, most are without screens now, water is able to penetrate the building, the molding around the windows is rotting out. Good windows are crucial for a well-maintained, energy-efficient and safe building. **Bid Marsh Building \$121,000**

Outside Door Replacements Over the last several years we have been able to replace a few outside doors on the building. We have four left that we would like to replace. The age of the doors varies from 15 years to 30 years old. **Current estimate/quote is \$5,400**

Painting of exterior of The Watkins Building We have no date as to when the building was last painted. A painting of whole outside of building is needed once the windows and doors are replaced. **Current quote is \$17,000**

Signage Signage has always been an issue for us because we have so many entrances. Now that we rent space to other nonprofits on our second floor it is more important to direct their clients to their offices. Our vision for the future growth of organizations and resources in this building makes better signage that much more important. Having three to four social programs going on daily, directing people has been very difficult because we need to have more professional signs made for us. **Current estimate from all vendors totals \$37,880** for install of one large digital sign for our property.

2. Interior of Watkins Building

Lighting Replacement This is needed for the whole building. We are what is called a Green Chalice Church for our denomination, which means that we take steps to change

our old technology when we can to newer green options. The lighting in the building needs to be upgraded. **Bid: All Phase Lighting \$9,700**

Ceiling Tile Replacement—We have in-house employees that can handle this type of remodel. The estimate for the material is **\$1,000**

Painting and Carpet—We intend to update all the carpet on the first floor in three rooms and paint those rooms. (Helping Hands, WWB and a processing donations room) **The estimated costs are \$16,710**

Water Fountain replacement—Our fountain is very important for our clients and the downtown area. We would like to install a bottle accessible fountain. The cost is estimated at **\$1,400**

As part of the renovations for first floor, **Signage** is necessary. **This estimate is \$2,200**

3. Partnership Improvements

Shalom Room renovation/remodel on First Floor—The Church is partnering with St James Place through a grant to house a Social Worker. An office on the first floor needs to be created for the person to meet with clients. Tasks to be completed are; construction of the space, furniture, painting, some electrical additions, and moving HVAC ducting. **Total estimates for this project are \$15,000**

Second floor shared office space remodel

Remodeling for Rooms—Creating another office for rental space for a non-for-profit group will help with on-going costs with the building as well as build partnership among human service agencies. We envision the Watkins Building as a hub for providing resources, shared programming, a sort of a “one-stop-shop” to better serve our vulnerable neighbors. We see the potential for an active, welcoming space for people to access food,

support, and meaningful friendships in this newly renovated space. The following is need for remodeling, carpet, painting, construction, furniture and fixtures. **Total estimated for this project is \$58,725**

4. HVAC System

The current HVAC system chiller was replaced in 2018, but the replacement of each of the fan coil units in the building was put on hold due to funding. Many if not all the units date to the 1970's. Each year we work on a few at a time, but it is costing more to maintain what we have than to purchase new units. Some of the units simply do not work due to the unavailable parts it would take to fix the unit. Those areas of the building are simply warmer than others. **The fan coil units** must be replaced to make the Watkins Building safe, viable, and able to serve the numbers of people we serve currently and will in the future. These new units will save money in the future due to it being energy efficient. It is a good use of funds on this project. **Fan Coil Unit / Thermostat Replacement** is currently estimated at a cost replacement of **\$71,500 Hubbard Mechanical.**

Closing

As one can see, this grant proposal showing the need for operational investments and facility improvements is varied and complex. Central Christian Church believes we have the expertise, motivation, and tenacity to make these changes come to fruition by April, 2024. We see our outreach programming as dynamic, shifting, and evolving to meet the everchanging needs within our community. Making the Watkins Building live up to its potential with the ARPA funds will guarantee the promise we at Central Christian Church hold so dear.
