It is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed agreement as follows:

Section 5:

Is changed effective **March 1, 2022** to note the addition of a HANDS state Maternal, Infant, and Early Childhood Home Visiting (MIECHV) FFY20 grant funding of **\$70,319** to the Family Care Center. The Health Department's FFY20 MIECHV grant payment to Family Care Center shall not exceed a total of **\$70,319**.

Line item maximal amounts for FFY20 MIECHV funding are as follows, unless prior approval has been granted from the HANDS Central Office:

- Administration = \$32,945
- Outreach = \$37,374

Is changed effective **March 1, 2022** to note the addition of a HANDS state Maternal, Infant, and Early Childhood Home Visiting (MIECHV) ARP FFY21 grant funding of **\$8,124** to the Family Care Center. The Health Department's FFY21 MIECHV ARP grant payment to Family Care Center shall not exceed a total of **\$8,124**.

Line item maximal amounts for FFY21 MIECHV ARP funding are as follows, unless prior approval has been granted from the HANDS Central Office:

- Program Administration = \$450
- Rise Training = \$1,301
- Emergency Kits = \$5,101
- Grocery Gift Cards = \$1,272

Family Care Center will work with Lexington-Fayette County Health Department Community Health leadership to expense the MIECHV and ARP funding allocation. Lexington-Fayette County Health Department will procure and distribute approved Family Care Center goods and services at the request of Family Care Center. Family Care Center MIECHV and ARP funding-related salary expenses will be reported to Lexington-Fayette County Health Department for reimbursement. No administrative fee will be deducted from the MIECHV funding awarded. Family Care Center's ARP grant funding will be expensed in full by 6/30/2022. Failure to expense grant funding in full by 6/10/2022 will result in redistribution of remaining ARP funding to Lexington-Fayette County Health Department. Family Care Center's MIECHV grant funding will be expensed in full by 8/31/2022. Failure to expense grant funding in full by 8/31/2022 will result in redistribution of remaining MIECHV to Lexington-Fayette County Health Department.
