A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS WITH DOWNTOWN LEXINGTON CORPORATION (\$1,500.00), MOVEABLE FEAST (\$2,000.00), BROKE SPOKE (\$1,175.00), TRANSYLVANIA PARK NEIGHBORHOOD ASSOCIATION (\$1,000.00), HISTORIC WOODWARD HEIGHTS NEIGHBORHOOD ASSOCIATION (\$500.00), MENTELLE NEIGHBORHOOD ASSOCIATION (\$1,500.00), LEXINGTON BLAZIN' CATS TRACK AND FIELD CLUB, LLC (\$3,325.00), AFRICAN AMERICAN FORUM, INC. (\$1,000.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUMS STATED.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
