AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO PROVIDE FUNDS FOR PURCHASE ORDERS AND PRE-PAID EXPENSES ROLLING FROM FY 2015 INTO FY 2016, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO 0004.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to provide funds for purchase orders and pre-paid expenses rolling from FY 2015 into FY 2016:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to provide funds for purchase orders and pre-paid expenses rolling from FY 2015 into FY 2016, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$ 2,733,956.36 \_ from\_ the Unappropriated Fund Balance in the General Services District-General Fund \_to\_ various accounts.

) \$ 4,140,449.79 \_ from\_ the Unappropriated Fund Balance in the Full Urban Services District Fund \_to\_ various accounts.

) \$ 25,286.62 \_ from\_ the Unappropriated Fund Balance in the Police Confiscated Federal Fund \_to\_ various accounts.

) \$ 3,150.00 \_ from\_ the Unappropriated Fund Balance in the Public Safety Fund \_to\_ various accounts.

) \$ 3,638,235.54 \_ from\_ the Unappropriated Fund Balance in the Municipal Aid Program Fund \_to\_ various accounts.

) \$ 150,570.22 \_ from\_ the Unappropriated Fund Balance in the County Aid Program Fund \_to\_ various accounts.

) \$ 131,027.97 \_ from\_ the Unappropriated Fund Balance in the Mineral Severance Fund \_to\_ various accounts.

) \$ 59,510.28 \_ from\_ the Unappropriated Fund Balance in the Coal Severance Fund \_to\_ various accounts.

) \$ 1,472.50 \_ from\_ the Unappropriated Fund Balance in the Police Confiscated Treasury Fund \_to\_ various accounts.

) \$ 3,647,610.10 \_ from\_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund \_to\_ various accounts.

) \$ 55,480.50 \_ from\_ the Unappropriated Fund Balance in the PFC – Parks Project Fund \_to\_ various accounts.

) \$ 700,641.13 \_ from\_ the Unappropriated Fund Balance in the Water Quality Management Fund \_to\_ various accounts.

) \$ 121,541.75 \_ from\_ the Unappropriated Fund Balance in the Landfill Fund \_to\_ various accounts.

) \$ 416,602.93 \_from\_ the Unappropriated Fund Balance in the Enhanced 911 Fund \_to\_ various accounts.

) \$ 3,894.33 \_from\_ the Unappropriated Fund Balance in the Central Kentucky 911 Fund \_to\_ various accounts.

) \$ 106,994.00 \_from\_ the Unappropriated Fund Balance in the Medical Insurance Fund \_to\_ various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0004", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
