AGREEMENT

THIS AGREEMENT, made and entered into on the ______ day of _____ 2025, by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government of the COMMONWEALTH OF KENTUCKY created pursuant to KRS Chapter 67A ("Lexington"), 200 East Main Street, Lexington, Kentucky 40507, and GREATER LEX, INC., a Kentucky non-profit corporation, ("Greater Lex") with offices located at 330 East Main Street, Suite 100, Lexington, Kentucky.

WITNESSETH:

WHEREAS, the Lexington-Fayette Urban County Government previously assisted Commerce Lexington, Inc. ("Commerce Lex") with creating and funding a Regional Economic Development Collective (or hereinafter the "Initiative") to support counties within the Bluegrass Region of Kentucky, including Bourbon, Clark, Fayette, Franklin, Jessamine, Madison, Montgomery, Scott, and Woodford ("the Counties"), by entering into a series of agreements to provide funding to Commerce Lex for efforts related to the Initiative; and

WHEREAS, the Lexington-Fayette Urban County Government and Commerce Lex agreed that a separate not for profit entity should be created to administer the Initiative, and Greater Lex, Inc., has been created specifically to do so; and

WHEREAS, to assist Greater Lex, Inc. in the administration of the Initiative, the Lexington-Fayette Urban County Government and Commerce Lex assigned the December 31, 2021 and the November 14, 2022 agreements which provided funding for the Initiative to the non-profit organization; and

WHEREAS, the Lexington-Fayette Urban County Government invested \$322,000.00 for the Initiative for Fiscal Year 2025; and

WHEREAS, the Lexington-Fayette Urban County Government desires to further invest \$320,154.00 for the Initiative for Fiscal Year 2026; and

WHEREAS, the Lexington-Fayette Urban County Government wishes to continue to partner with Greater Lex to administer this regional economic development planning and collaboration initiative; and

WHEREAS, the Lexington-Fayette Urban County Government ("Lexington") has determined that this Initiative fulfills a public purpose by providing for economic development assistance; and

NOW, **THEREFORE**, in consideration of the mutual promises and covenants set forth herein, the receipt and sufficiency of which are acknowledged, the parties hereby agree as follows:

- 1. This Agreement shall commence on July 1, 2025 and shall last until June 30, 2026.
- 2. Greater Lex, will administer the Regional Economic Development Collaborative ("the Initiative"), as further described in Section 3 and the attached Exhibit A (Scope of Work), which is incorporated herein by reference as if fully stated, on behalf of Lexington.
- 3. Lexington shall provide Greater Lex with Three Hundred and Twenty Thousand and One Hundred Fifty-Four Dollars and 00/100 Cents (\$320,154.00) (""Funds") in funding for the Initiative, contingent upon the final approval by the Urban County Council of the Lexington-Fayette Urban County Government's Fiscal Year 2026 budget, which

- 6. If Exhibit B shows that the remaining eight participating counties in the nine-county region, excluding Fayette County, did not provide their full pro rata funding based on their population size in accordance with Exhibit B, Lexington will make final payment based on the percentage of the remaining eight counties' required combined contribution that was actually provided as of May 1, 2026. Notwithstanding the foregoing, if the above mentioned percentage is not equal to or greater than fifty percent (50%), Lexington shall have the option to withhold the remaining fifty percent (50%) of the Funds.
- 7. Greater Lex shall not require membership in Commerce Lexington or any other regional chamber or organization to participate. Upon notification of any such requirement for membership, this Agreement and Organization's services to Lexington shall automatically become void.
- 8. No later than January 1, 2026 Greater Lex shall provide to the CDO a full listing of the Greater Lex Executive Board and Full Board of Directors including their government or private sector employer and job title.
- 9. At the call of the Chair, Greater Lex shall provide the Lexington Economic Development Investment Board and the Urban County Council Budget, Finance and Economic Development Committee with an annual organization budget update once it has been approved by the Greater Lex board. Greater Lex will also provide Lexington with regular progress updates on the program pursuant to this Agreement on at least a semi-annual basis to the Lexington Economic Development Investment Board and shall appear before the Urban County Council or any of its committees to provide progress updates upon Lexington's reasonable request. Greater Lex shall also complete the

must be spent on Lexington's behalf in a manner consistent with paragraph 4 and the attached Exhibit A (Scope of Work), unless otherwise agreed to by the parties. Greater Lex agrees that the Funds provided under this Agreement shall be used only for local economic development and workforce development efforts of the project. No funds provided under this Agreement shall be expended on administrative costs. 4. The Initiative is a collaboration between governmental and economic development partners across the Bluegrass on the following non-excusive list of priorities:

- a) Emphasizing strategies to increase workforce participation in the region;
- b) Improving availability and affordability of housing for the region;
- c) Developing new leaders and engage more people in regional collaboration efforts;
- d) Working within the region to have a supply of shovel-ready sites for economic development projects;
- e) Investing more regionally in workforce/job training efforts;
- f) Emphasizing on infrastructure improvements; and
- g) Providing more work experience for students in the region.
- 5. Lexington shall provide fifty percent (50%) of the Funds upon execution of this Agreement and a submitted invoice. Greater Lex shall provide a fully executed Exhibit B, which is incorporated herein by reference as if fully stated, by December 31, 2025 and May 1, 2026. If Exhibit B shows that the remaining eight participating counties in the nine-county region, excluding Fayette County, provided their full pro rata funding based on their population size in accordance with Exhibit B by May 1, 2026, Lexington shall provide the remaining fifty percent (50%) of the Funds.

reports provided as the attached Exhibits B, C, and D and provide to Lexington by December 31, 2025 and May 1, 2026.

- 10. Greater Lex will keep and make available to Lexington any records related to this Agreement such as are necessary to support its performance thereof. Books of accounts shall be kept by Greater Lex and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of Greater Lex related to this Agreement and shall be made available to Lexington upon request. This provision shall survive the termination or expiration of this Agreement.
- 11. Either party may terminate this Agreement for a material breach in performance after placing the breaching party with written notice of the breach and the opportunity to cure. The period to cure the breach shall be reasonable, but in all instances must be at least thirty (30) days. Any unencumbered funds held by Greater Lex at the time of termination of this Agreement shall be returned to Lexington within (30) days of receiving notice. In the event Greater Lex is dissolved any such funds attributed to Lexington shall be returned to Lexington within thirty (30) days of said dissolution.
- 12. Greater Lex shall keep itself fully informed of all national and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and shall indemnify Lexington, its officers, agents and employees against any claim or liability arising from and based on Greater Lex's violation of any such laws, ordinances or regulations. This indemnification provision shall survive the termination or expiration of this Agreement.

- 13. Unless otherwise provided herein, each party shall be solely responsible for its actions and those of its officials, employees and agents in the performance of this contract and any matters related thereto. This provision shall survive the termination or expiration of this Agreement.
- 14. In no event shall the parties be construed, held or become in any way for any purpose the employee of the other party, or partners, associates or joint ventures in the conduct of their respective endeavors or otherwise.
- 15. Greater Lex shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex, age, sexual orientation or gender identity, or handicap, shall promote equal employment through a positive, continuing program of equal employment, and shall cause any agency receiving funds provided pursuant to this Agreement to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.
- 16. Greater Lex represents that is has adopted, or will adopt, a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be made available to Lexington upon request.
- 17. Lexington may designate such persons as may be necessary to monitor and evaluate the services rendered hereunder by Greater Lex. Lexington, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and

monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the responsibility or obligations of Greater Lex.

- 18. Greater Lex agrees that all revenue and expenditures shall be audited at least annually by independent certified public accountants who shall express an opinion as to whether or not revenue and expenditures during the year audited have conformed to state and local law and regulation. A copy of this audit shall be submitted to the Government within ten (10) days of completion.
- 19. Notice Any written notice required by the Agreement shall be delivered by certified mail, return receipt requested, to the following:

- 20. Neither party may assign any of its rights and duties under this Agreement without the prior written consent of the other party.
- 21. This Agreement does not create a contractual relationship with or right of action in favor of a third party against either Greater Lex or Lexington.
- 22. If any term or provision of this Agreement shall be found to be illegal or unenforceable, this Agreement shall remain in full force and such term or provision shall be deemed stricken.

23. This Agreement shall be governed in all respects by the laws of the Commonwealth of Kentucky and venue for all actions shall lie in Fayette County, Kentucky.

24. By mutual agreement, the parties to this Agreement may, from time to time, make written changes to any provision hereof. Greater Lex acknowledges that Lexington may make a material change only upon approval of its legislative authority, the Lexington-Fayette Urban County Council, and the signature of its Mayor.

25. This Agreement shall constitute the entire agreement between the parties and no representations, inducements, promises or agreements, oral or otherwise, which are not embodied herein shall be effective for any purpose. This Agreement shall replace any previous agreement between the parties on the same subject matter.

26. The waiver by either party of any breach of any provision of this Agreement shall not constitute a continuing waiver or waiver of any subsequent breach by either party of either the same or another provision of this Agreement.

IN WITNESS WHEREOF, the parties certify that they have been duly authorized to execute, deliver and perform this Agreement, and have executed it as of the date first herein written.
