Summary and Motions

Chair Dave Sevigny called the meeting to order at 1:00 p.m. Committee Members James Brown, Tyler Morton, Tom Eblen, Emma Curtis, Liz Sheehan, Lisa Higgins-Hord, Joseph Hale, Amy Beasley, and Hil Boone were in attendance as voting members. Council Member Shayla Lynch was present as a non-voting member.

I. APPROVAL OF MARCH 3, 2026 COMMITTEE SUMMARY

Motion by Morton to approve the March 3, 2026 Environmental Quality & Public Works Committee Summary. Seconded by Sheehan. Motion passed unanimously.

II. PAVEMENT MANAGEMENT PLAN

Acting Commissioner Charlie Martin presented the FY27 update to the Pavement Management Plan. Lexington continues to use pavement condition surveys and the Overall Condition Index (OCI) to resurface streets with an OCI below 60. The Administration proposed a \$13 million paving budget, including approximately \$5.2M for local roads, \$3.25M for collectors, \$3.25M for arterial/service-industrial roads, and \$1.3M for preventive maintenance. An additional \$1M is dedicated to ADA ramp improvements and \$200,000 to pothole repairs. Local funding distribution is based on each Council district's proportion of lane miles scoring below 60.

The update also emphasized coordination with utilities, a paving calendar spanning fiscal years, the continued success of the Paving Sharing Program, and future initiatives such as improved ArcGIS mapping, evaluation of national best practices, right-of-way restoration policy updates, and refinement of pavement classifications.

III. COMPLETE STREETS DESIGN MANUAL UPDATE

Consultant Bert Kuyrkendall presented progress on the new Complete Streets Design Manual (CSDM), intended to align Lexington's transportation design standards with the City's Complete Streets (2022) and Vision Zero (2023) policies. The manual consolidates and updates guidance from multiple regulatory documents, including subdivision regulations and traffic management guidance.

It covers street typologies, multimodal corridor design, pedestrian and bicycle infrastructure, intersection design, roundabouts, speed management, landscaping, utilities, and pavement standards.

Staff noted significant stakeholder engagement—working groups, workshops, and coordination with engineering, development, and utility partners. Feedback continues on topics such as alley standards, bikeway details, truck turning movements, utility placement, drainage, project cost considerations, and right-of-way needs. A revised draft is set for public release in May 2026, with Council review planned for Summer 2026 and subsequent Planning Commission review later in the year.

IV. PARKING CITATIONS DURING WINTER WEATHER EMERGENCIES

LexPark Executive Director Laura Boison presented an overview of existing and proposed winter-weather citation protocols. During a formal snow emergency declared by the Mayor, LexPark would provide free overnight parking in select downtown garages from 6 p.m. to 8 a.m., dependent on availability and event-related demand. Enforcement would be limited to major safety hazards and vehicles obstructing operations.

For significant snow or ice events without an emergency declaration, LexPark proposes reduced garage rates and limited citation activity. Enforcement is relaxed when accumulation exceeds 4 inches or when major ice conditions exist, but ADA and major safety violations remain enforceable.

The presentation also described operational challenges, legal constraints in existing parking ordinances, recent examples from winter storms in 2025 and 2026, and coordination needs between LexPark, LFUCG, and snow-route management efforts.

V. CONSENT DECREE AND REMEDIAL MEASURES PLAN

Charlie Martin provided an update on the federal sanitary sewer Consent Decree and the Remedial Measures Plan. The final compliance deadline has been extended from December 31, 2026 to December 31, 2030. Of the 113 required projects, 91 are complete or removed, 12 are under construction, and 10 major projects remain, including several large wet-weather storage tanks (Town Branch Phase 2, North Elkhorn, and Mint Lane).

Other active projects include major trunk sewers and pump station upgrades across the county. Some projects are expected to conclude in 2026, with others extending into 2027. Approximately 81% of capital work is complete, with overall costs trending below original 2014 projections despite inflation and construction cost pressures.

The program aims for all remaining projects to be under construction by January 1, 2029 to meet the extended deadline.

VI. ITEMS REFERRED TO COMMITTEE

Motion by Sheehan to remove *Parking Citations During Winter Weather Emergencies* from the list of items referred to committee. Seconded by Higgins-Hord. Motion passed without dissent.

The meeting adjourned at 2:25 pm.

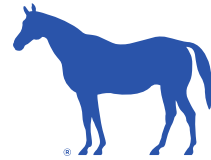

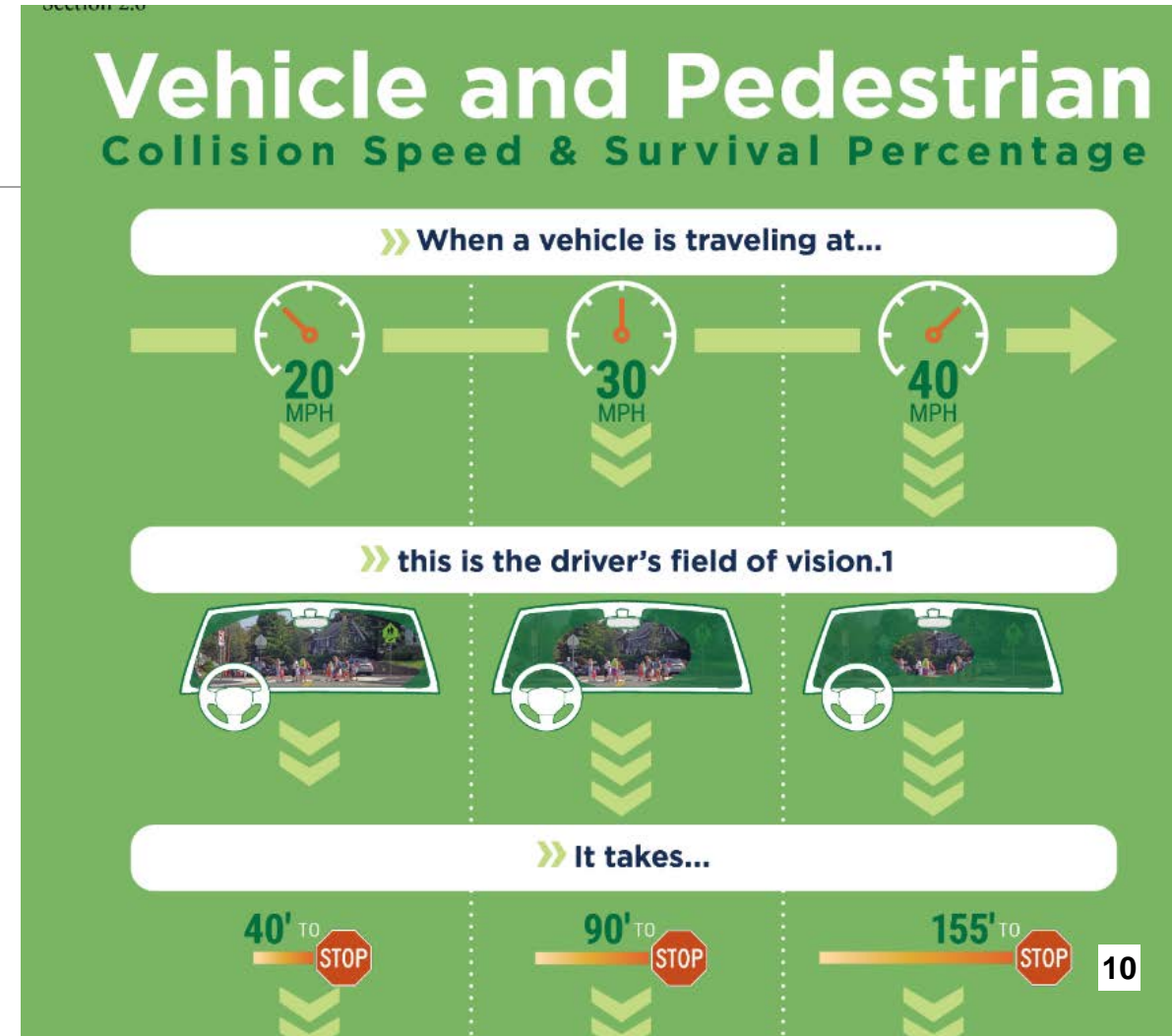

What has changed?

 The standard bikeway is:	Uncomfortable for most users	Comfortable and fully separated from traffic
 The standard intersection is:	Difficult to enforce safe driving	Keeps traffic flowing while reducing serious crashes and injuries
 Traffic calming features:	Require more costly retrofits	Gets it right the first time

What has changed?

 Planting strip widths are:	Not wide enough for large trees	Make sure large trees can survive



How is the Manual implemented?

What is Sustainability?

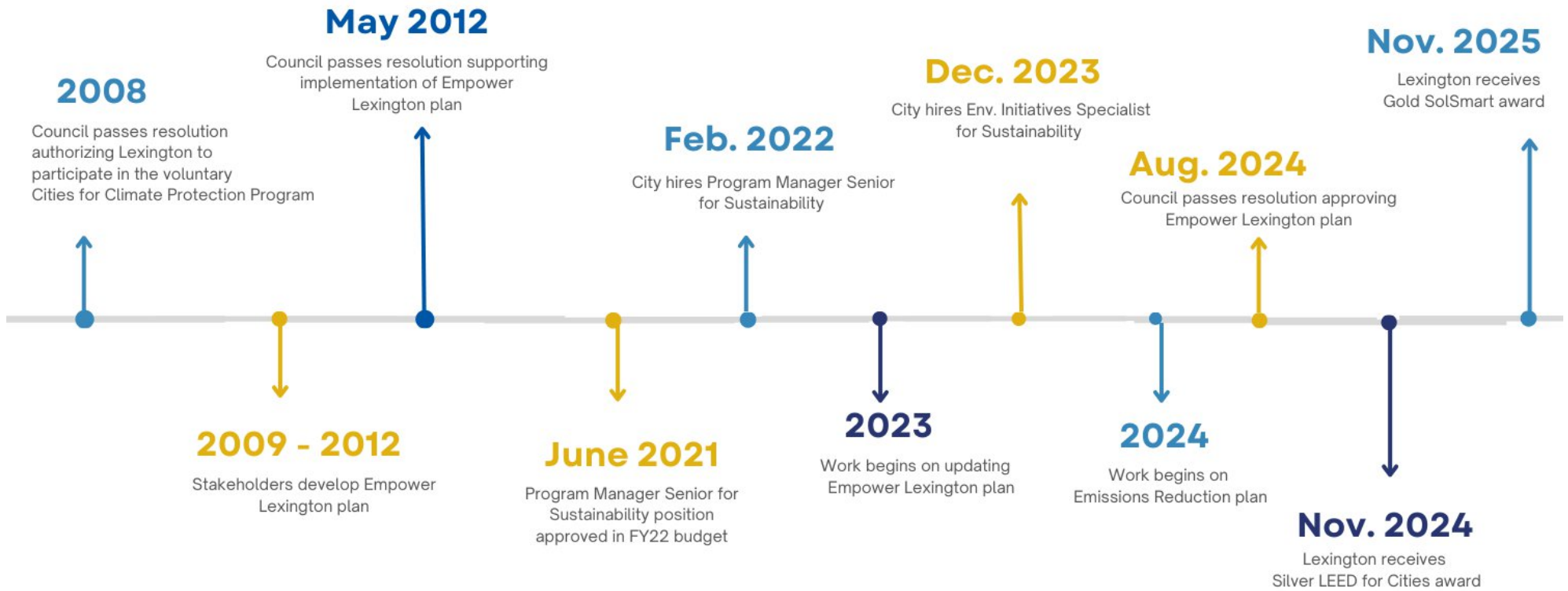

It involves three main areas:

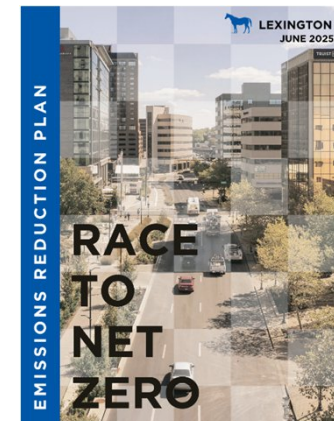
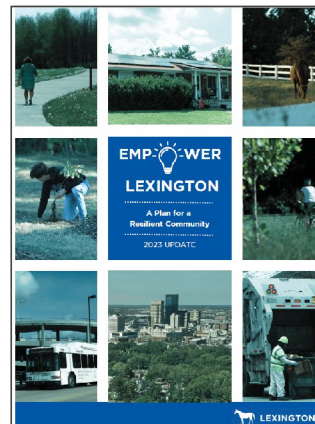
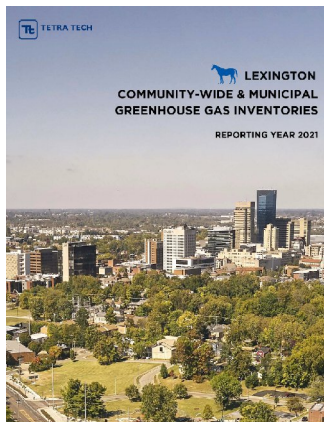
1. Environment: Protecting natural resources and reducing pollution to keep our planet healthy.

Solarize Lexington Program

- 2023 and 2024 partnered with KY Solar Energy Society to provide a vetted process for residents
- Group-buying program designed to promote and encourage the use of solar
- Open only to Lexington-Fayette County residents, small businesses, non-profits, and places of worship
- Council approved \$1M both years for grants to low- to moderate-income homeowners (< 80% Area Median Income [AMI])
- A total of 128 residential solar installations (84 grants)

\$1,986,684.40 of grant funding disbursed

Solarize Lexington Program

2026

- Launch June 10
- LFUCG managing program without partnership
- Restructured and expanded program to include all six counties in the Lexington-Fayette County, KY Metropolitan Statistical Area, which includes the counties of Bourbon, Clark, Fayette, Jessamine, Scott, and Woodford
- Council approved \$460,000 for grants to be used only for low- to moderate-income homeowners (< 80% Area Median Income) waitlisted since the 2024 program
- Installer: Solar Energy Solutions

Green Check

- Free sustainable certification program for businesses, nonprofits, and places of worship
- Started in 2016
- More than 80 businesses have gone through the program
- Green Check scorecard awards points for green initiatives in 10 categories
- Levels include Member, Bronze, Silver, and Gold
- Certification is valid for 3 years
- Current class includes 6 new businesses and 14 recertifications

Spin-off Initiative: Green Cup, a partnership with local coffee shops to encourage customers to bring their reusable cups and receive a discount.

Common Threads LEX

- Sustainability-focused partnership between LFUCG, the University of Kentucky, and Fayette County Public Schools
- Energize a community-wide dialogue about our shared goals and empower residents, students, and families
- Kickoff event was held in March with the screening of *Microplastic Madness* and a panel discussion at the Kentucky Theatre
- Pre-film event included tabling by environmental groups and a reusable items swap
- Plan to hold 2-3 events per year



Beat the Heat

- Launched August 2025
- Partnership with Division of Emergency Management, Senior Center, Fire & EMS, and Office of Homelessness Intervention and Prevention
- Cooling kits contain a cooling towel, reusable water bottles, electrolyte powder, sunscreen, aloe, tips on staying cool, and a list of cooling stations
- Public health intervention for most vulnerable populations during extreme heat

It's hot. Stay safe!

- + Wear sunglasses and/or a hat.
- + Wear loose, lightweight clothing in light colors.
- + Avoid direct sunlight. Stay in the shade.
- + When outside, avoid unnecessary activity.
- + Wet a cloth. Wear it around your neck.
- + Avoid coffee, alcohol and drinks with lots of sugar.
- + Don't wait until you are thirsty. Drink water - more than normal. Sports drinks are also helpful.
- + Visit a cooling center.

When the Extreme Heat Plan has been activated, Lextran will offer free rides to cooling stations.

Signs of heat-related illnesses include:

- + Red, hot and dry skin (no sweating)
- + Rapid, strong pulse
- + Throbbing headache
- + Dizziness; nausea; confusion
- + Muscle cramps
- + Tiredness and unconsciousness



If someone starts to experience these symptoms, **seek medical help immediately**. Move them to a shady spot. Begin cooling them. Continue cooling efforts until help arrives.

Other Initiatives

Pickleball Recycling

- Launched April 2024
- Partnership between Sustainability Section, Parks and Recreation, and the Kentucky Pickleball Association
- Currently, 2 bins located at Shillito Park with plans to add some to Kirklevington in coming weeks
- Collected pickleballs are recycled through P3 Cares
- 1,160 pickleballs recycled so far = more than 69 pounds of plastic diverted from landfill

Climate Pollution Reduction Planning Grant

Regional Planning

- Lexington-Fayette County Metropolitan Statistical Area
 - Includes Fayette, Bourbon, Clark, Scott, Jessamine, and Woodford Counties

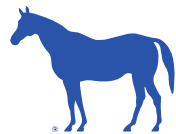

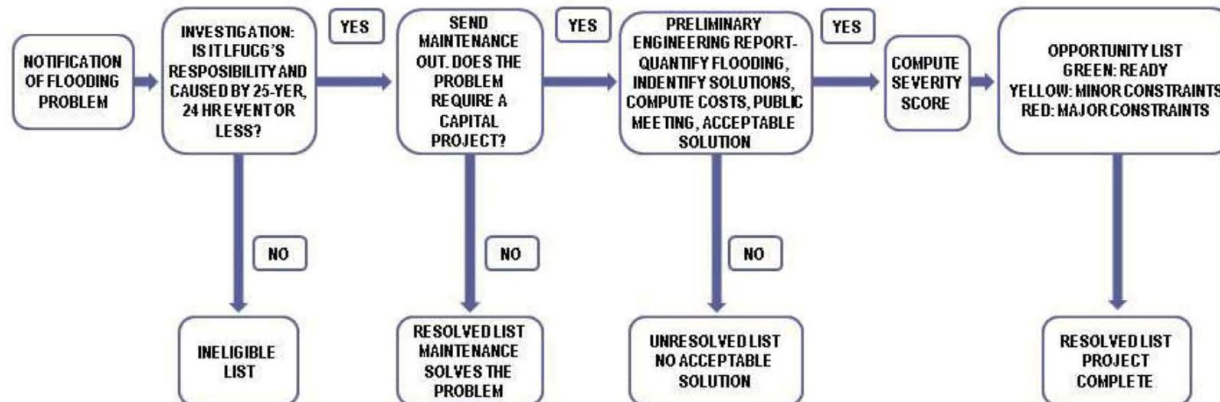

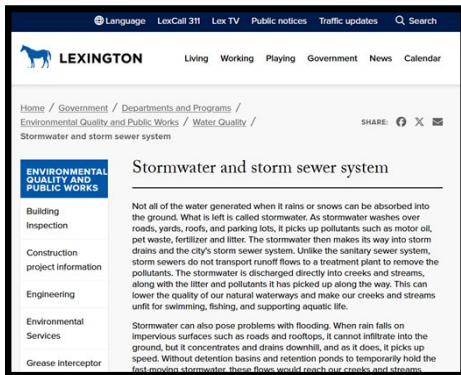
HOW DOES A PROPERTY GET CONSIDERED FOR INCLUSION ON THE STORMWATER PRIORITY LIST?

For storm events less than the 25-year, 24-hour event (5.23 inches) – at least one of the following conditions must be met:

- Structure flooding (surface water entering a structure through an opening such as a door, window, or vent); or
- Street/road flooding with either greater than 1 foot of water in the driving lane or the crown of the road is not visible.

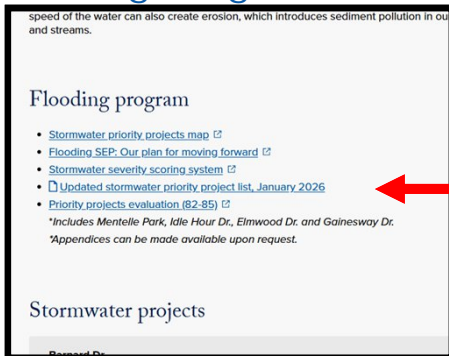

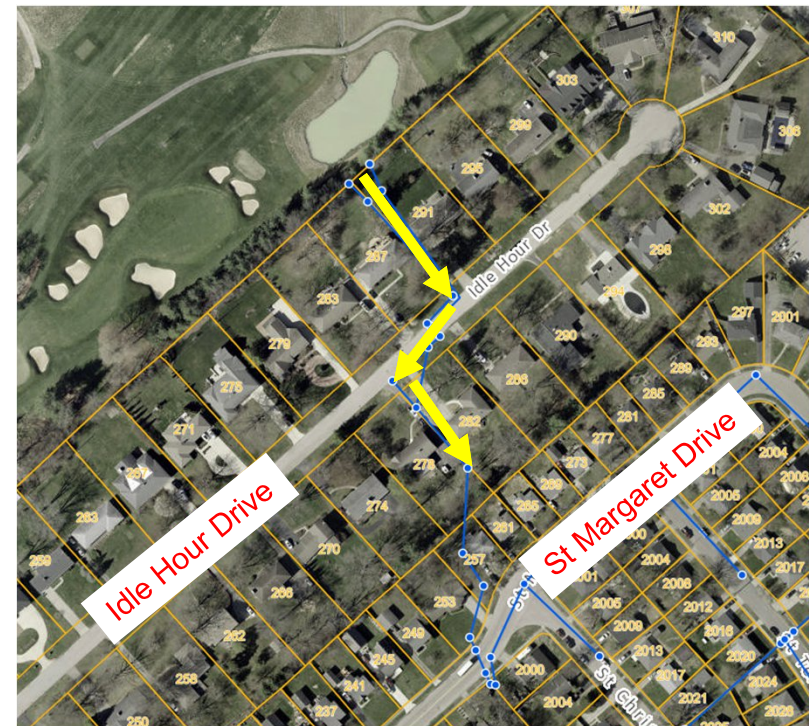

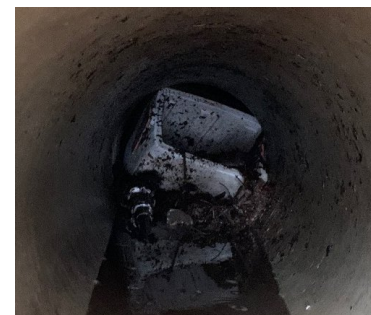
