A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE CONTRACT MODIFICATION NO. 1 TO THE ENGINEERING SERVICES AGREEMENT WITH CDP ENGINEERS, INC., FOR DESIGN OF SOUTHLAND DRIVE BIKE LANE PROJECT, INCREASING THE CONTRACT AMOUNT BY THE SUM OF \$15,669.00 FROM \$49,886.00 TO \$65,555.00.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:


Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute a Contract Modification, which is attached hereto and incorporated herein by reference, to the Engineering Services Agreement with CDP Engineers, Inc., for design of Southland Bike Lane Project.

Section 2 - That an amount, not to exceed the sum of \$15,669.00, be and hereby is approved for payment to CDP Engineers, Inc., from account # 3160-303202-90313, pursuant to the terms of the Contract Modification.

Section 3 - That this Resolution shall become effective on the date of its passage.

On January 12, 2012 (Resolution No. 4-2012), Council approved execution of an Engineering Services Agreement in the amount of \$49,886 with CDP Engineers, Inc., for the design of the Southland Drive Bike Lane Project, from Nicholasville Road to Rosemont Garden.

Additional compensation in the amount of \$15,669 is requested because the entire roadway will now be resurfaced using other funds. This resurfacing requires additional surveying and striping plan. Other additional costs include improvements at the Regency Road intersection and an access management plan. New design total is \$65,555.
