

**1<sup>ST</sup> AMENDMENT TO THE HEALTH SERVICES AGREEMENT**  
**between**  
**LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**  
**DIVISION OF COMMUNITY CORRECTIONS**  
**and**  
**CHS TX, INC. d/b/a YESCARE**

**THIS 1<sup>ST</sup> AMENDMENT**, by and between the Lexington-Fayette Urban County Government, Division of Community Corrections (the "Division") and CHS TX, Inc. d/b/a YesCare ("YesCare") (hereinafter collectively referred to as the "Parties"), is effective as of the First of July, 2025 (the "Effective Date").

**WITNESSETH:**

**WHEREAS**, the Division is charged by law with the responsibility for administering, managing and supervising the health care delivery system at the Adult Detention Center located at 600 Old Frankfort Circle, in Lexington, Kentucky (the "Facility"); and

**WHEREAS**, YesCare provides correctional health care staffing and services and desires to provide such staffing and services for the Division under the terms and conditions of this Health Services Agreement (the "Agreement"); and

**WHEREAS**, the parties entered into a Health Services Agreement for YesCare to provide such services to the Division, effective July 1, 2024; and

**WHEREAS**, the parties now desire to amend certain terms related to staffing as set forth herein.

**NOW, THEREFORE**, with the intent to be legally bound, and in consideration of the covenants and promises hereinafter made, the Parties hereto agree as follows:

1. The staffing plan included in Section 2.1(a) shall be deleted in its entirety and shall be replaced with the staffing plan included in this amendment. The staffing plan modifications include moving 1.4 FTE RN MAT from night shift to day shift. The Competency Restoration Program has reduced the Forensic Psychiatrist from 0.5 FTE to 0.3 FTE.

2. The Parties agree that the reduction of Forensic Psychiatry hours will reduce the annual contract value by \$65,000 starting the second year of the contract. Section 9.1 Base Compensation is hereby revised to the following:

9.1 Base Compensation. The Division will pay YesCare the sum of \$10,278,132 for the first year of this Agreement for a daily average base inmate population between 1,180 and 1,380 inmates, payable in equal monthly installments of \$856,511 per month. Compensation for the second year of this agreement will be \$11,343,840, payable in equal monthly installments of \$945,320. Compensation for the third year of this Agreement will be 11,718,480, payable in equal monthly installments of \$976,540.

3. Appendix B – Staff Vacancy Rates shall be deleted in its entirety and replaced with the updated Appendix B – Staff Vacancy Rates for Contract Year Two incorporated here into this amendment. In addition to the Psychiatrist FTE reduction, the rate schedule corrects the Competency Program Behavioral Health Registered Nurse to Behavioral Health Licensed Practical Nurse, and the required Competency Restoration FTE for Psychiatrist and Behavioral Health Technician.

All other terms and conditions of the Agreement shall remain unchanged and in full force and effect except to the extent modified herein.
