 (“CP Provider” or “Subcontractor”)**

The Amendment is made effective as of the Date listed above (the “Effective Date”) to that certain Subcontract between CP Provider and MedAware dated \_\_\_\_\_ in connection with the MedAware Community Paramedicine Program in the Kentucky Medicaid Market (the “CP Provider Subcontract”).

1. The last sentence of the first paragraph of the “Member Care Plan (“MCP”) section of Paragraph 3 of the CP Provider Subcontract is revised to clarify that the number of anticipated total home visits for each Member under the applicable MCP as follows:

“The anticipated number of total visits needed to reach objectives is eight (8) visits, expandable up to ten (10) total visits if requested and approved per the MCP.”

2. The second sentence in the first paragraph of the “Home Visits” section of Paragraph 3 of the CP Provider Subcontract is hereby deleted in its entirety and replaced with the following language:

“Typically, a Home Visit will occur minimally once per week, and at most two times per week, and will typically have a duration of sixty (60) minutes or less.”

3. The first two paragraphs in the “Pricing/Fee Structure” table of Paragraph 9 of the CP Provider Subcontract are amended to change the fees that MedAware will pay to CP Providers as follows:

“MedAware will pay CP Provider **\$120** for the initial in-home assessment (defined above).”

“For each Home Visit or authorized TeleHealth Visit made to an Elevance Member by CP Provider, MedAware will pay CP Provider **\$120.**”

4. The fourth and final main bullet point in the “Billing – Invoicing” section of Paragraph 9 of the CP Provider Subcontract is hereby deleted in its entirety and replaced with the following language:

- “MedAware will invoice Elevance on a monthly basis based on CP Provider’s monthly report of MIH Services provided to Elevance Members. MedAware will pay CP Provider based on the timing of Elevance’s payments to MedAware for each invoice as follows: (a) within twenty (20) days of the date of the invoice, less a two percent (2%) discount, or (b) within ninety (90) days of the date of the invoice, with no discount.”

5. Except as expressly amended above, the remainder of the CP Provider Subcontract shall remain in full force and effect.

IN WITNESS WHEREOF, the undersigned have read, understood and executed this Amendment to CP Provider Subcontract agree to be bound by its provisions as of the Effective Date.
