

RESOLUTION NO. 543 - 2016

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS WITH FOOD CHAIN (\$500.00), LEXINGTON HUMANE SOCIETY (\$500.00), MEADOWTHORPE NEIGHBORHOOD ASSOCIATION, INC. (\$500.00), POLICE ATHLETIC/ACTIVITIES LEAGUE OF LEXINGTON, INC. (\$1,000.00), LEXARTS, INC. (\$400.00), VINEYARD NEIGHBORHOOD CORP. (\$1,165.00), AND LAFAYETTE BAND ASSOCIATION (\$500.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUMS STATED.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute agreements, which are attached hereto and incorporated herein by reference with Food Chain, Lexington Humane Society, Meadowthorpe Neighborhood Association, Inc., Police Athletic/Activities League of Lexington, Inc., LexArts, Inc., Vineyard Neighborhood Corp. and Lafayette Band Association, for the Office of the Urban County Council.

Section 2 - That an amount, not to exceed the sum stated, be and hereby is approved for payments to Food Chain (\$500.00), Lexington Humane Society (\$500.00), Meadowthorpe Neighborhood Association, Inc. (\$500.00), Police Athletic/Activities League of Lexington, Inc. (\$1,000.00), LexArts, Inc. (\$400.00), Vineyard Neighborhood Corp. (\$1,165.00) and Lafayette Band Association (\$500.00) from account #1101 121002 71299, from various Council Districts, pursuant to the terms of the agreement.
