Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County

-) \$1,750.00 from the Unappropriated Fund Balance in the General Service District General Fund to various accounts.
-) \$25.00 from the Unappropriated Fund Balance in the Donations Fund to various accounts.
-) Re-appropriations within the General Service District General Fund and various grant funds which do not result in changes to the Unappropriated Fund Balance of these funds.
- Section 2 That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0010" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
