## **AMENDMENT TO RESOLUTION NO. 419-2011**

## INTERLOCAL COOPERATION AGREEMENT

This Amendment to the Interlocal Cooperation Agreement ("Agreement") made and entered into on the 27<sup>th</sup> day of May, 2011, as authorized by Section 9 of the Agreement, by and between the Lexington-Fayette Urban County Government (LFUCG) on behalf of the Lexington Division of Police and the Jessamine County Kentucky Sheriff.

## **WITNESSETH:**

WHEREAS, recent construction of homes at or near the borders of Fayette and Jessamine Counties, has presented an issue where parts of homes and associated property with legitimate Fayette County addresses, and or access to homes and associated property with legitimate Fayette County addresses, cross county border lines. This can create confusion with regard to the use of legal authority by sworn officers of the Lexington Division of Police who respond to calls for service at the addresses, and enforce laws on the property of these addresses that rests inside the Jessamine County border. This amendment will allow such jurisdiction and law enforcement power to be exercised in Jessamine County by regular full-time sworn Lexington Division of Police personnel who are trained pursuant to KLEFF standards for police officers in Kentucky and shall include the authority to conduct investigations and searches, make arrests, seize property pursuant to applicable law, carry firearms, execute search and arrest warrants, deliver subpoenas and summonses issued under authority of law, and perform other law enforcement duties and activities, as directed by the Chief of Police or his designee.

NOW THEREFORE, the Agreement is amended as follows:

1. Section 3 is amended to include the following properties:

All homes, structures and properties, including curtilage, easements, and right of ways, addressed on the Fayette County streets of Ashley Oaks Dr, Bridlewood Ln, Hemlock Way, Hobbs Way, and Mandeville Way.
