

ORDINANCE NO. 063 - 2025

AN ORDINANCE AMENDING THE CIVIL SERVICE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) UNCLASSIFIED POSITION OF FRIEND OF THE COURT, GRADE 523E, AND CREATING ONE (1) UNCLASSIFIED POSITION OF FRIEND OF THE COURT, GRADE Z17, ESTABLISHING THE SALARY RANGE FOR GRADE Z17, WITH A MINIMUM OF \$2,501.92 BIWEEKLY AND A GRADE MAXIMUM OF \$3,753.04 BIWEEKLY, AND REALLOCATING THE INCUMBENT; AND ABOLISHING FIVE (5) UNCLASSIFIED POSITIONS OF FAMILY COURT SERVICES SPECIALIST, GRADE 516N, AND CREATING FIVE (5) UNCLASSIFIED POSITIONS OF FAMILY COURT SERVICES SPECIALIST, GRADE Z85; ESTABLISHING THE SALARY RANGE FOR GRADE Z85 WITH A GRADE MINIMUM OF \$23.339 PER HOUR AND GRADE MAXIMUM OF \$35.007 PER HOUR, AND REALLOCATING THE INCUMBENTS, ALL EFFECTIVE THE FIRST PAY PERIOD FOLLOWING COUNCIL APPROVAL.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That subsection line numbers 164.010 and 164.015 be and hereby are deleted.

Section 2 – That the following subsection line numbers in the unclassified civil service authorized strength be and hereby are created to read as follows:

164.010	1	024	Z17	Friend of the Court
164.015	5	025	Z85	Family Court Services Specialist

Section 3 – That the salary range for Grade Z17 is hereby established with a minimum of \$2,501.92 biweekly and a maximum of \$3,753.04 biweekly. The salary range for Grade Z85 is hereby established with a minimum of \$23.339 per hour and a maximum of \$35.007 per hour.

Section 4 – That the following incumbent be and hereby is reallocated, with no change in biweekly rate:

Duane Osborne, from Friend of the Court, Grade 523E, at \$4,280.96 biweekly, to Friend of the Court, Grade Z17, at \$4,280.96 biweekly.

Section 5 – That the following incumbents be and hereby are reallocated, with no change in hourly rate:

Elizabeth Wilson, from Family Court Services Specialist, Grade 516N, at \$33.339 hourly, to Family Court Services Specialist, Grade Z85, at \$33.339 hourly.

Kanika Persley, from Family Court Services Specialist, Grade 516N, at \$28.961 hourly, to Family Court Services Specialist, Grade Z85, at \$28.961 hourly.

Davina Warner, from Family Court Services Specialist, Grade 516N, at \$35.558 hourly, to Family Court Services Specialist, Grade Z85, at \$35.558 hourly.

Angelica Maldonado, from Family Court Services Specialist, Grade 516N, at \$32.357 hourly, to Family Court Services Specialist, Grade Z85, at \$32.357 hourly.

Vanessa Dennis, from Family Court Services Specialist, Grade 516N, at \$27.581 hourly, to Family Court Services Specialist, Grade Z85, at \$27.581 hourly.

Section 6 – That this Ordinance shall be effective the first pay period following Council approval.
