AN ORDINANCE EXPANDING AND EXTENDING THE FULL URBAN SERVICES DISTRICT #1 FOR THE URBAN COUNTY GOVERNMENT FOR THE PROVISION OF STREET LIGHTING, STREET CLEANING, GARBAGE AND REFUSE COLLECTION, TO INCLUDE THE AREA DEFINED AS CERTAIN PROPERTIES ON THE FOLLOWING STREETS: ARMATURE COURT, ASH RAPIDS, BAY SPRINGS PARK, BEAUMONT CENTRE CIRCLE, BRYANT ROAD, CATTLE PATH, CORDELE LANE, CRAVAT PASS, CROCUS COURT, DANBY WOODS DRIVE, ELIZABETH STREET, ESTRELLA DRIVE, GREENDALE ROAD, HARRINGTON COURT, HARRODSBURG ROAD, HEMP HILL DRIVE, INDUSTRY ROAD, INNOVATION DRIVE, LARCH TREE PARK, LEESTOWN ROAD, LIBERTY ROAD, LOBLOLLY COURT, MABLE LANE, MADISON POINT DRIVE, MAGNOLIA SPRINGS DRIVE, MALONE DRIVE, MARBELLA LANE, MILL RIDGE ROAD, MOONCOIN WAY, MULUNDY WAY, NEWTOWN COURT, NEWTOWN SPRINGS DRIVE, NICHOLASVILLE ROAD, OLD HOUSE ROAD, OLD MT TABOR ROAD, OLD ROSEBUD ROAD, OLD SCHOOLHOUSE LANE, PARKER MEADOWS, PEAKS MILL DRIVE, REAL QUIET LANE, ROSETTE WAY, ROUNDWAY DOWN LANE, RUSSELL CAVE ROAD, RUTLEDGE AVENUE, SANDERSVILLE ROAD, SILVER CHARM LANE, SORRELL WAY, SPURR ROAD, ST ANDREWS WALK, STOLEN HORSE TRACE, STRASBURG PARK, SULLIVANS TRACE, SUNDOLLAR COVE, TRACERY OAKS DRIVE, VINCENT WAY, WAVELAND MUSEUM LANE, WILSON DOWNING ROAD, AND WINNING COLORS LANE.

WHEREAS, pursuant to Section 2.03 of the Charter of the Lexington-Fayette Urban County Government, Resolution No. 693-2022 was enacted by the Urban County Council on December 6, 2022, specifying the intention of the Urban County Government to expand and extend the Full Urban Services District #1; and

WHEREAS, pursuant to Section 2.03 of the Charter of the Lexington-Fayette Urban County Government, Resolution No. 693-2022 was published in the Lexington Herald-Leader; and

WHEREAS, pursuant to KRS 67A.860, certified letters were mailed to property owners to be affected by the expansion and extension of the Full Urban Services District #1, informing them of the proposed expansion and extension and the time and place of a public hearing; and

WHEREAS, pursuant to Section 2.03 of the Charter of the Lexington-Fayette Urban County Government and KRS 67A.860, a public hearing was held on January 24, 2023 to inform and receive the views of all interested persons concerning the expansion and extension of the Full Urban Services District #1.

NOW, THEREFORE, PURSUANT TO SECTION 2.03 OF THE CHARTER
OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT AND KRS

67A.150, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

SECTION 1 – That the Full Urban Services District #1 for the Lexington-Fayette Urban County Government, for the provision of street lighting, street cleaning, and garbage and refuse collection, be and hereby is expanded and extended to include an area defined as the following properties, lots, tracts, and parcels of land within the Full Urban Services District #1:
