- b      [1077-17](#)      Authorization to execute Amendment to Agreement with Sunflower Kids, Inc. extending the period of performance through September 30, 2018 for provision of supervised visitation and safe exchange services for victims of domestic violence, child abuse, sexual assault, and stalking. No additional cost in this Fiscal Year. (L1077-17) (Theakston/Ford)
- c      [1086-17](#)      Authorization to execute an Amendment to the provisions set forth in Bid #36-2017 Commissary Services for Community Corrections at no additional cost.
