

GRANT OF EASEMENT

This **EASEMENT** is made and entered into this ^{L m.R.W} 6th day of NOVEMBER, 2013, by and between **MALCOM R. WADLINGTON, JR. and ANDREA A. WADLINGTON, husband and wife**, 1215 Mt. Rushmore Way, Lexington, Kentucky 40515 ("Grantors"), which is also the in-care of tax mailing address for the current tax year, and the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507 ("Grantee");

WITNESSETH:

That for and in consideration of the sum of **Eight Thousand Seven Hundred Twenty-Three Dollars and 20/100 Cents (\$8,723.20)**, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and do hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, the permanent right to lay, construct, operate, repair, reconstruct and remove sanitary sewer improvements and appurtenances thereto, which sanitary sewer improvements and appurtenances shall be of such dimension, character, construction and use determined by Grantee, along, through, under and across the following tract of land located in the confines of Lexington-Fayette County, Kentucky, and more particularly described as follows:

Permanent Sanitary Sewer Easement
1213 Mt. Rushmore Way
Century Hills Sanitary Sewer Improvement Project

Described on Exhibit A attached hereto and incorporated herein by reference.

FURTHER, for and in consideration of the foregoing sum, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and

do hereby **GIVE, GRANT and CONVEY** unto the Grantee, its successors and assigns, the temporary right to excavate, grade, construct, alter, regrade and perform related work for the purpose of sanitary sewer construction, repair, installation and relocation through and across the following tract of land located within the confines of Lexington-Fayette County, Kentucky, to-wit:

Temporary Construction Easement
2013 Mt. Rushmore Way
Century Hills Sanitary Sewer Improvement Project

All temporary construction easements, if any, are described on Exhibit B attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD the above-described easement together with all rights, privileges, appurtenances and improvements thereunto belonging unto Grantee, its successors and assigns forever, for the purposes and uses herein designated.

The above-described temporary construction easement will expire upon completion of the construction of the improvement project on the land adjacent to this easement, runs with the land for the duration of the improvement project on the adjacent land, and is binding upon the heirs and assigns of the Grantors.

Grantors do hereby covenant to and with said Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the easements conveyed herein, and that they will **WARRANT GENERALLY** said title.

Grantors shall have the full right to use the surface of the land lying over said permanent easement for any purpose desired, provided such use will not interfere with the Grantee's free use of the easement herein granted and provided further that no building or structure shall be erected upon, across, over or through said permanent easement without the prior written consent of the Grantee.

The obtaining of this easement was authorized by Resolution No. 389-2013

All those tracts or parcels of land situated on the southerly side of Mt. Rushmore Way at its terminus, southeasterly from its intersection with Pimlico Parkway, in Lexington, Fayette County, Kentucky, and more fully described and bounded as follows, to-wit:

Permanent Sanitary Sewer Easement:

Beginning at a point in the common line of Lot 38A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 790) and Lot 37A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 648; see Plat Cabinet B, Slide 631), said point being approximately 95 feet northeasterly from the rear common corner of said lots as measured along said common line; thence along the common line of Lots 38A and 37A, N 27° 30' 04" E 20.26 feet; thence through Lot 38A, S 53° 20' 30" E 73.44 feet to a point in the common line of Lot 37A aforesaid and Lot 90, Block D, Unit 2-E of Century Hills Subdivision (Plat Cabinet C, Slide 27); thence along said common line, S 27° 30' 04" W 20.26 feet; thence again through Lot 38A, parallel with and twenty feet southwesterly from the second call cited above, N 53° 20' 30" W 73.44 feet to the beginning and containing 1469 square feet.

Temporary Construction Easement - Tract 1:

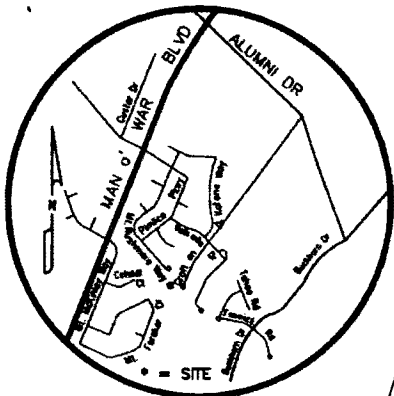
Beginning at the northwesterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 38A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 790) and Lot 37A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 648; see Plat Cabinet B, Slide 631); thence along said common line, N 27° 30' 04" E 10.13 feet; thence through Lot 38A, parallel with and ten feet northeasterly from the northeasterly line of the above described permanent sanitary sewer easement, S 53° 20' 30" E 73.44 feet to a point in the common line of Lot 37A aforesaid and Lot 90, Block D, Unit 2-E of Century Hills Subdivision (Plat Cabinet C, Slide 27); thence along said common line, S 27° 30' 04" W 10.13 feet; thence again through Lot 38A, along the northeasterly line of the above described permanent sanitary sewer easement, N 53° 20' 30" W 73.44 feet to the beginning and containing 734.5 square feet.

Temporary Construction Easement - Tract 2:

Beginning at the southwesterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 38A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 790) and Lot 37A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 648; see Plat Cabinet B, Slide 631); thence through Lot 38A, along the southwesterly line of the above described permanent sanitary sewer easement, S 53° 20' 30" E 73.44 feet to a point in the common line of Lot 37A aforesaid and Lot 90, Block D, Unit 2-E of Century Hills Subdivision (Plat Cabinet C, Slide 27); thence along said common line, S 27° 30' 04" W 10.13 feet; thence again through Lot 38A, parallel with and ten feet southwesterly from the southwesterly line of the above described permanent sanitary sewer easement, N 53° 20' 30" W 73.44 feet to a point in the common line of Lots 38A and 37A aforesaid; thence along said common line, N 27° 30' 04" E 10.13 feet to the beginning and containing 734.5 square feet.

Being a twenty-foot wide permanent sanitary sewer easement and ten-foot wide temporary construction easements on a portion of the same property conveyed to Grantors by deed dated August 26, 2005, and of record in Deed Book 2581, Page 473; being designated as Lot 38A, Block D, Unit 2-B of Century Hills Subdivision as per the Amended Final Record Plat of record in Plat Cabinet D, Slide 790. All of the above referenced instruments are of record in the Fayette County Clerk's office.

Not To Scale

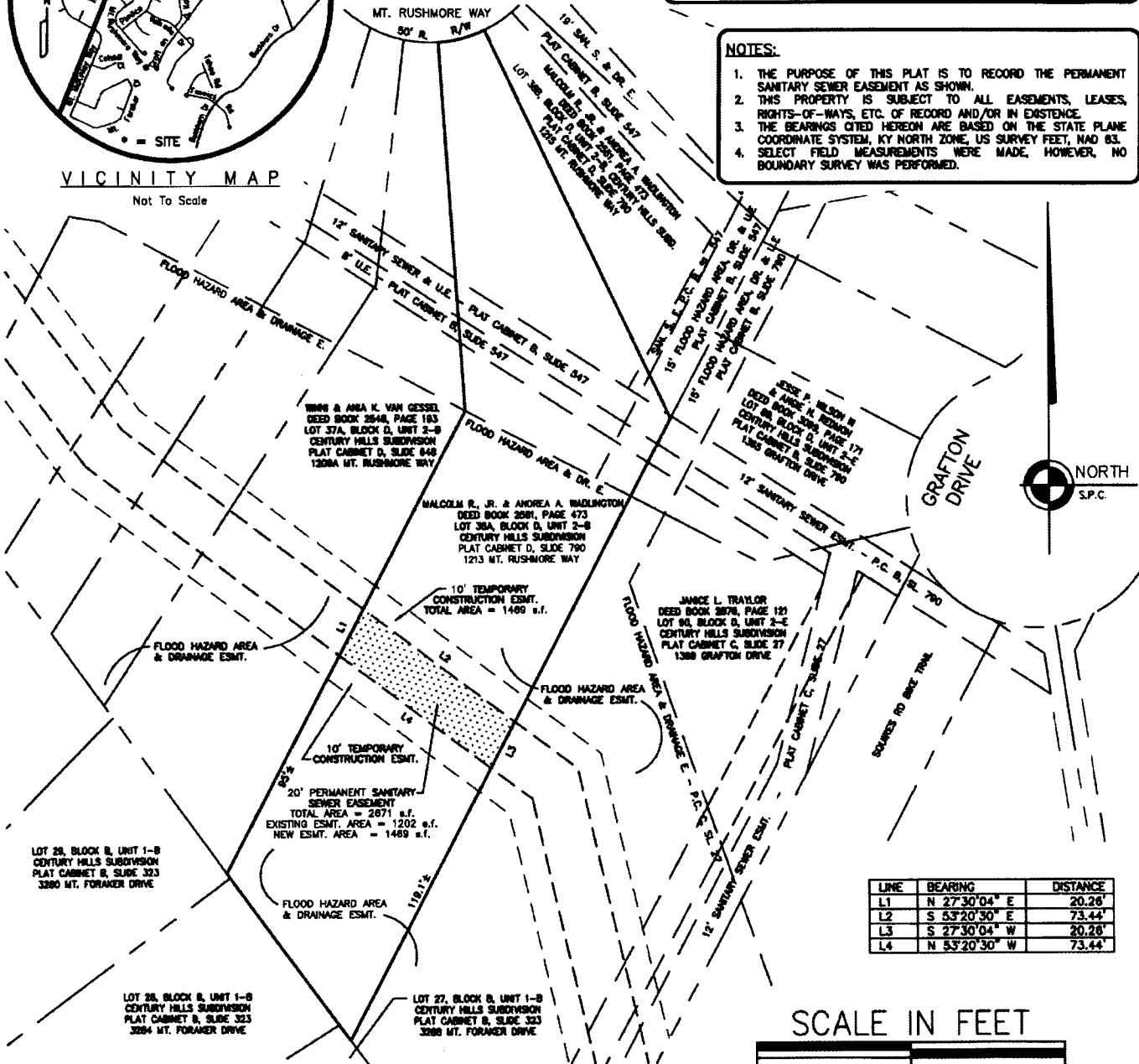

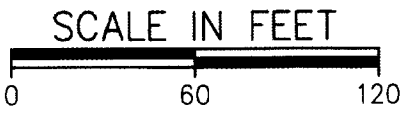
