(\$1,000.00), BIG BROTHERS/BIG SISTERS OF THE BLUEGRASS, INC. (\$225.00), BLUEGRASS TECHNOLOGY CENTER, INC. (\$350.00), YMCA OF CENTRAL KY (\$400.00), HOPE CENTER, INC. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
