 SCOPE OF WORK AND BUDGET**

Scope of Work:

The scope of work for this project includes PE, environmental, design engineering and construction for a shared use trail from existing bike lanes/sidewalks on Citation Boulevard through the Mable Lane Greenway, continuing to Masterson Hills Park and to Jacquelyn Drive.

Budget:

This supplemental agreement adds the construction phase funding for this project and reduces the design phase funds to free up excess federal funds from the design phase for use in the construction phase.
