The County Clerk further requests, that with the amount of \$5,195,000.00 requested for salaries, F.I.C.A., Retirement and Insurance that he/she be allowed to employ up to 80 deputies with the understanding that all deputies will serve at the pleasure of the said County Clerk with the County Clerk having full power of substitution from time to time as he/she may see fit. Finally, the County Clerk requests discretionary funds of \$5,000.00 for personnel support in the form of retirement and holiday celebrations, wellness program, and other related incidental expenses.
