A RESOLUTION CHANGING THE PROPERTY STREET NAME OF 519-531 LAKETOWER DRIVE TO 531 LAKETOWER DRIVE, 142-144 NORTH BROADWAY TO 144 NORTH BROADWAY, 347-349 SOUTHLAND DRIVE UNIT 1 TO 347 SOUTHLAND DRIVE, 347-349 SOUTHLAND DRIVE UNIT 2 TO 349 SOUTHLAND DRIVE, 1954 STANTON WAY TO 1950 STANTON WAY AND CHANGING THE STREET NAME AND PROPERTY ADDRESS NUMBER OF 970 WEST NEW CIRCLE ROAD TO 1196 FINNEY DRIVE, 980 WEST NEW CIRCLE ROAD TO 1192 FINNEY DRIVE, 990-992 WEST NEW CIRCLE ROAD TO 1188 FINNEY DRIVE, 996 WEST NEW CIRCLE ROAD TO 1184 FINNEY DRIVE, 1000 WEST NEW CIRCLE ROAD TO 1180 FINNEY DRIVE, 1004 WEST NEW CIRCLE ROAD TO 1172 FINNEY DRIVE, 1008 WEST NEW CIRCLE ROAD TO 1156 FINNEY DRIVE, 1010 WEST NEW CIRCLE ROAD TO 1160 FINNEY DRIVE, 1040 WEST NEW CIRCLE ROAD TO 1164 FINNEY DRIVE, ALL EFFECTIVE THIRTY (30) DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property street name of the following property be and hereby is changed as follows:

(a) Laketower Drive

- (a) West New Circle Road: That the name of West New Circle Road located at 970 is changed to Finney Drive and the following number change is made:
