AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO REFLECT CURRENT REQUIREMENTS FOR MUNICIPAL EXPENDITURES, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO. 0053.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$_1,485,147.88_ _from_ the Unappropriated Fund Balance in the General Service District General Fund _to_ various accounts.
-) \$_4,000.00_ _ from_ the Unappropriated Fund Balance in the Full Urban Service District Fund _to_ various accounts.
-) \$_1,179,858.25.00_ _ from_ the Unappropriated Fund Balance in the Municipal Aid Program Fund _to_ various accounts.
-) \$_500.00_ _from_ the Unappropriated Fund Balance in the US Department of Health and Human Services Grant Fund _to_ various accounts.
-) \$_420,079.00_ _to_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund _from_ various accounts.
-) $\$_47,000.00_$ _from_ the Unappropriated Fund Balance in the PFC General Fund _to_ various accounts.
-) \$_146,405.99_ _to_ the Unappropriated Fund Balance in the Water Quality Management Fund _from_ various accounts.
 -) \$_22,500.00_ _from_ the Unappropriated Fund Balance in the Landfill Fund _to_ various accounts.
-) Re-appropriations within the General Service District General Fund; Donation Fund; Full Urban Service District Fund; Sanitary Sewer Construction Fund; Police and Fire Retirement Fund; and the various grant funds which do not result in changes to the Unappropriated Fund Balance of these funds.
- Section 2 That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0053" attached hereto and incorporated herein by reference.
 - Section 3 That this Ordinance shall become effective on the date of its passage.
