A RESOLUTION CHANGING THE STREET NAMES OF 6291 JACKS CREEK PIKE TO 6291 OLD JACKS CREEK ROAD AND OF 3454 MADDOX LANE TO 3454 BRILLIANT LANE; CHANGING THE PROPERTY ADDRESS NUMBERS OF 5925 PARKERS MILL ROAD TO 5954 PARKERS MILL ROAD, OF 3316 BUCKHORN DRIVE TO 3318 BUCKHORN DRIVE, OF 429 GEORGETOWN STREET TO 431 GEORGETOWN STREET, AND OF 2499 NICHOLASVILLE ROAD TO 2483 NICHOLASVILLE ROAD; AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 5708 VERSAILLES ROAD TO 5924 PARKERS MILL ROAD, OF 1624 OLD PARIS ROAD TO 139 EAST NEW CIRCLE ROAD, OF 1799 BATTERY STREET TO 2389 PATCHEN WILKES DRIVE, AND OF 127-129 N. LIMESTONE TO 101 WEST SHORT STREET, ALL EFFECTIVE THIRTY DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the street names of the following properties be and hereby are changed as follows:

- (a) <u>Jacks Creek Pike:</u> That the name of Jacks Creek Pike located at 6291 Jacks Creek Pike is changed to Old Jacks Creek Road.
- (b) <u>Maddox Lane</u>: That the name of Maddox Lane located at 3454 Maddox Lane is changed to Brilliant Lane.

Section 2 – That the property address numbers of the following properties be and hereby are changed as follows:

(a) Parkers Mill Road:

(a) <u>Versailles Road:</u> That the name of Versailles Road located at 5708 Versailles Road is changed to Parkers Mill Road and the following number change is made:

(b) Old Paris Road: That the name of Old Paris Road located at 1624 Old Paris Road is changed to East New Circle Road and the following number change is made:

(c) <u>Battery Street:</u> That the name of Battery Street located at 1799 Battery Street is changed to Patchen Wilkes Drive and the following number change is made:
