Eileen O'Donnell, Administrative Specialist Sr., Grade 112N, \$17.141 hourly in the Department of Law, effective December 3, 2013.


Tamarah Gross, Administrative Specialist, Grade 110N, \$16.615 hourly in the Division of Revenue, effective December 24, 2013.
